SYNOPSIS

A resolution has been prepared to authorize the execution of a Local Agency Agreement between the Village of Downers Grove and the Illinois Commerce Commission (ICC) for a roadway safety improvement project at the Maple Avenue crossing of the Burlington Northern Santa Fe Railroad (BNSFRR).

STRATEGIC PLAN ALIGNMENT

The Five Year Plan and Goals identified *Top Quality Village Infrastructure and Facilities*.

FISCAL IMPACT

Approval of the proposed agreement would authorize the Village to receive grant funding from the ICC from their Grade Crossing Protection Fund (GCPF) program at Maple Avenue. Per the proposed agreement, the ICC would provide the Village with grant funding in the amount of 90% (\$262,800) of the total costs of the project. The Agreement stipulates that the Village is responsible for the remaining 10% of the costs of the project, which is anticipated to be \$29,200. The Village has applied for a grant for its 10% portion of the project and has received notification from the Illinois Jobs Now Program that funding has been ear-marked for this item. The FY10 budget does not include funds for this project. However, if the project proceeds as planned, the Village has funds available in Capital Projects Fund for any expenses incurred in FY10 and will budget accordingly for the project in FY11.

UPDATE & RECOMMENDATION

This item was discussed at the April 13, 2010 meeting. Staff recommends approval on the April 20, 2010 active agenda.

BACKGROUND

The Village initiated a dialogue with the ICC in early 2009 seeking funding assistance to address the severe roadway profile on Maple Avenue at the BNSF Railroad crossing. This location was the scene of a fatal traffic accident in 2007. At the ICC's request, staff prepared and submitted preliminary plans for this project in July, 2009. After reviewing the plans and the location ICC staff expressed concern with the limited sight distance for westbound vehicles on Burlington Road who are turning left to go south / westbound on Maple Avenue. After reviewing several design alternatives, staff recommends that Burlington Avenue be reconfigured to prohibit westbound traffic on Burlington Avenue west of Grand. Eastbound traffic on Maple Avenue will continue to turn right on Burlington Avenue. An exhibit showing this reconfiguration of the traffic pattern is attached. There is a small volume of traffic that travels west bound on Burlington Avenue, 350 vehicles per day, and this change will not adversely affect the overall traffic pattern in this area.

The terms of the Local Agency Agreement are as follows:

- The Village will prepare detailed plans and cost estimate for the project and submit them to the ICC and to IDOT for review within 90 days of execution of this Agreement;
- The Village will issue the notice for bids and shall serve as the contracting agency;

- The Grade Crossing Protection Fund will provide 90% funding, up to \$262,800. Additional costs will be the responsibility of the Village;
- The Village will pay the contractor and the ICC will reimburse the Village as work occurs;
- The Village will provide a status report at six month intervals to the Commission; and
- The work is to be completed by November 2011.

Staff believes this is an important safety improvement. Following approval by the Village the agreement will be forwarded to for execution by the State. Engineering plans will be completed in-house and staff anticipates construction beginning as early as fall 2010.

That the Village Manager and Village Clerk are hereby respectively authorized and directed for and on behalf of the Village to execute, attest, seal and deliver the Agreement, substantially in the form approved in the foregoing paragraph of this Resolution, together with such changes as the Manager shall deem necessary.

3. That the proper officials, agents and employees of the Village are hereby authorized and directed to take such further action as they may deem necessary or appropriate to perform all obligations and commitments of the Village in accordance with the provisions of the Agreement.

4. That all resolutions or parts of resolutions in conflict with the provisions of this Resolution are hereby repealed.

5. That this Resolution shall be in full force and effect from and after its passage as provided by law.

STIPULATED AGREEMENT 1487**

This Agreement made and entered into, by and between the State of Illinois acting by and through the Illinois Commerce Commission ("Commission"), the BNSF Railway ("Company"), the Village of Downers Grove ("Village"), and the State of Illinois, Department of Transportation ("Department" or "IDOT").

WITNESSETH:

WHEREAS, it has come to the attention of the Commission through application for assistance from the Grade Crossing Protection Fund that inquiry should be made into the matter of improving public safety at the Maple Avenue highway-rail grade crossing ("crossing") of the Company's track in the Village of Downers Grove, in DuPage County, Illinois, designated as crossing AAR/DOT #079 533G, milepost 20.58; and

WHEREAS, proper investigation has been made of the circumstances surrounding the subject crossing by a representative of the Commission's Transportation Division Railroad Section; and

WHEREAS, the physical aspects, including geometrics of the intersection, train movements, vehicular traffic volume, and sight distances and other pertinent data relating to the crossing have been obtained and shown on Exhibit A, attached to this Agreement; and

WHEREAS, the parties are mutually agreeable to accomplish proposed improvements to the crossing upon determination of the Commission by Order.

NOW, THEREFORE in consideration of the premises and of the mutual covenants and agreements as hereinafter contained the parties pray that the Commission enter an Order according to the provisions of Section 18c-7401 of the Illinois Commercial Transportation Law, 625 ILCS 5/18(c)-7401, requiring that certain improvements as hereinafter stated be made and that the cost for the proposed improvements be divided among the parties according to law and that in the interest of the traveling public the Grade Crossing Protection Fund ("GCPF") of the Motor Fuel Tax Law ("MFT") be required to bear a substantial portion of the cost; To Wit the parties agree as follows:

Section 1 All improvements encompassed by this Agreement shall be made in accordance with all applicable State laws, rules, standards, regulations and orders and procedures in general.

Section 2 The parties are of the opinion that the following improvements in the interest of public safety at the subject crossing should be:

- (a) Improvement of the south highway approach to meet the minimum requirements of 92 Ill. Adm. Code 1535.204, by the Village of Downers Grove. This includes access modifications to the Maple Avenue and Burlington Avenue intersection, located adjacent to the Maple Avenue crossing, to prohibit all westbound Burlington Avenue traffic.

Section 3 The Village has prepared preliminary plans and a preliminary cost estimate to accomplish the proposed roadway improvements, which may be required by Commission Order. The drawings and cost estimate(s) are attached and incorporated herein by reference as Exhibit B and Exhibit C respectively.

The Village shall upon Order, according to the requirements contained therein, prepare and submit a copy of the detailed plans, estimates of cost and any required specifications for the proposed improvements to the Commission and the Department’s District 1 office for approval. The Village agrees that an appropriate time for the submission of plans should be ninety (90) days from the date of a Commission Order approving this Agreement.

The Department shall provide notice (via phone, electronic mail, standard mail, or fax) to the Commission within forty-five (45) calendar days after it has received the final construction drawings and estimates of cost and any required specifications for the proposed improvements from the Village. The notice shall indicate Department approval or disapproval of the final construction drawings, estimates of cost and any required specifications for the proposed improvements.

Section 4 The Village shall upon Order, according to the requirements contained therein, proceed toward the completion of the proposed improvements, accomplishing the work with its own forces or appropriate contracted services and agrees that an appropriate time for the completion of the proposed improvements should be November 1, 2011.

Section 5 The parties agree that an equitable division of cost for the proposed improvements is as follows:

- Notes:
1. Total Grade Crossing Protection Fund (GCPF) assistance not to exceed \$262,800; any installation costs above the estimated amount of \$292,000 will be the responsibility of the Village.
 2. The Village shall be responsible for all roadway design and construction engineering costs.
 3. The Village shall be responsible for all future maintenance costs associated with the highway approaches.

Section 6 The Village is financially able and willing to pay a portion of the cost for the proposed improvements as may be assigned by the Order and indicates this intent by Resolution incorporated herein by reference as Exhibit D. The Village shall submit a certified copy of the Resolution at the same time as the Execution Page of this Agreement is submitted to the Commission.

Section 7 Special Provisions: The Village shall complete and submit the Project Manager Information portion of the Project Status Report sheet, attached as Exhibit E, along with this executed Agreement.

The Village shall, at six (6) month intervals from the date of the Commission Order approving this Agreement, submit to the Director of Processing and Information, Transportation Bureau of the Commission, a Project Status Report, attached as Exhibit E, regarding the progress it has made toward completion of the work required by this Agreement. Each Project Status Report shall include the Commission Order's docket number, the Order date, the project completion date as noted in the Order, crossing information (inventory number and railroad milepost), type of improvement, and the name, title, mailing address, phone number, facsimile number, and electronic mailing address of the Village Project Manager.

All bills for work specified in Section 2 authorized for reimbursement from the Grade Crossing Protection Fund shall be submitted to the Department's District 1 Office, located at 201 W. Center Court, Schaumburg, IL 60196. The Department shall send a copy of all invoices to the Director of Processing and Information, Transportation Bureau of the Commission. All bills shall be submitted no later than twelve (12) months from the completion date specified in the Commission Order approving this Agreement. The final bill for expenditures from each party shall be clearly marked "Final Bill". The Department shall not obligate any assistance from the Grade Crossing Protection Fund for the cost of proposed improvements described in this Agreement without prior approval by the Commission. The Commission shall, at the end of the 12th month from the completion date specified in the Commission Order approving this Agreement, or any Supplemental Order(s) issued for this project, conduct a review to determine if any unused assistance from the Grade Crossing Protection Fund should be de-obligated. Upon completion of the review, the Commission shall notify the Department to de-obligate all residual funds accountable for installation costs for this project. Notification may be by regular mail, electronic mail, fax, or phone.

SECTION 8 Billing: For all work specified in Section 2 of this Agreement, and authorized by an Order of the Commission, the Village shall assure that sufficient documentation for all bills is made available for review by the Department of the Department's representative. The minimum documentation that must be made available is outlined below:

- a) Labor Charges (including additives) - Copies of employee work hours charged to the railroad and/or highway account code for the project.
- b) Equipment Rental - Copies of rental agreements for the equipment used, including the rental rate; number of hours the equipment was used and the railroad and/or highway account code for the project.
- c) Material - An itemized list of all materials purchased and installed at the crossing location. If materials purchased are installed at multiple crossing locations, a notation must be made to identify the crossing location.
- d) Engineering - Copies of employee work hours charged to the railroad and/or highway account code for the project.
- e) Supervision - Copies of employee work hours charged to the railroad and/or highway account code for the project.
- f) Incidental Charges - An itemized list of all incidental charges along with a written explanation of those charges.
- g) Service Dates - Invoice shall include the beginning and ending date of the work accomplished for the invoice.
- h) Final or Progressive - Each invoice shall be marked as a Progressive or a Final Invoice.
- i) Reference Numbers - Each invoice shall include the AAR/DOT number, the ICC Order number and the state job number when federal funds are involved.
- j) Locations - Each invoice shall show the location, with the street name and AAR/DOT crossing inventory number.

Section 9 This Agreement shall be binding upon the parties hereto, their successors or assigns. Upon execution of this Agreement by all parties, the Commission shall enter an appropriate Order, within 60 days accepting or rejecting such stipulation according to the provisions contained herein.

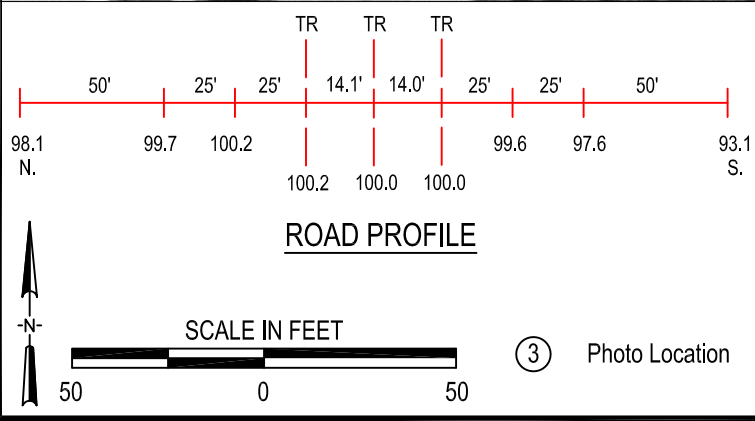
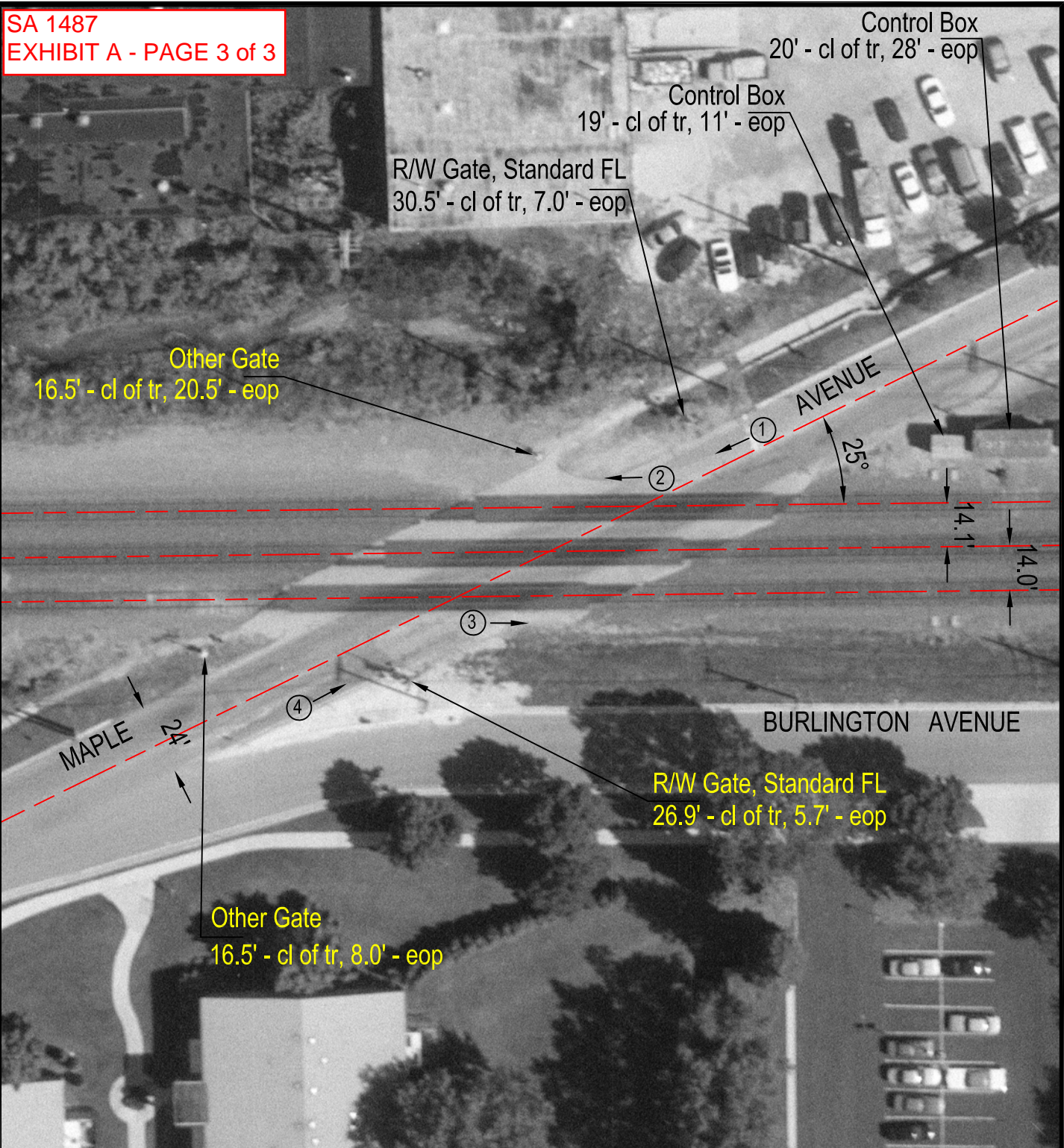

COMMENTS:

The south highway approach grade does not meet the minimum requirements of 92 Ill. Adm. Code 1535.204. The proposed improvements will permit the south approach to meet those requirements.

The agency with jurisdiction of a roadway is generally responsible for the costs associated with improvements to the highway approaches. However, with the extent of work needed, the Village has noted with current fiscal constraints, it can contribute only 10% towards the \$292,000 of estimated costs. The Village will also perform the design engineering work and construction engineering. In the interest of public safety staff of the Rail Safety Section recommends that the Grade Crossing Protection Fund be used to pay the remainder of the construction costs.

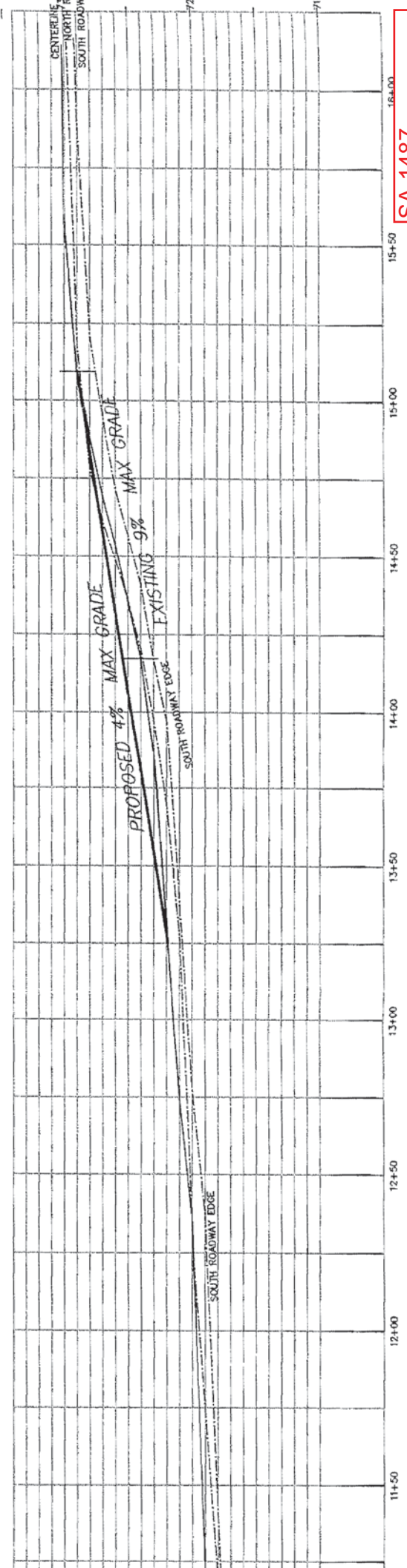

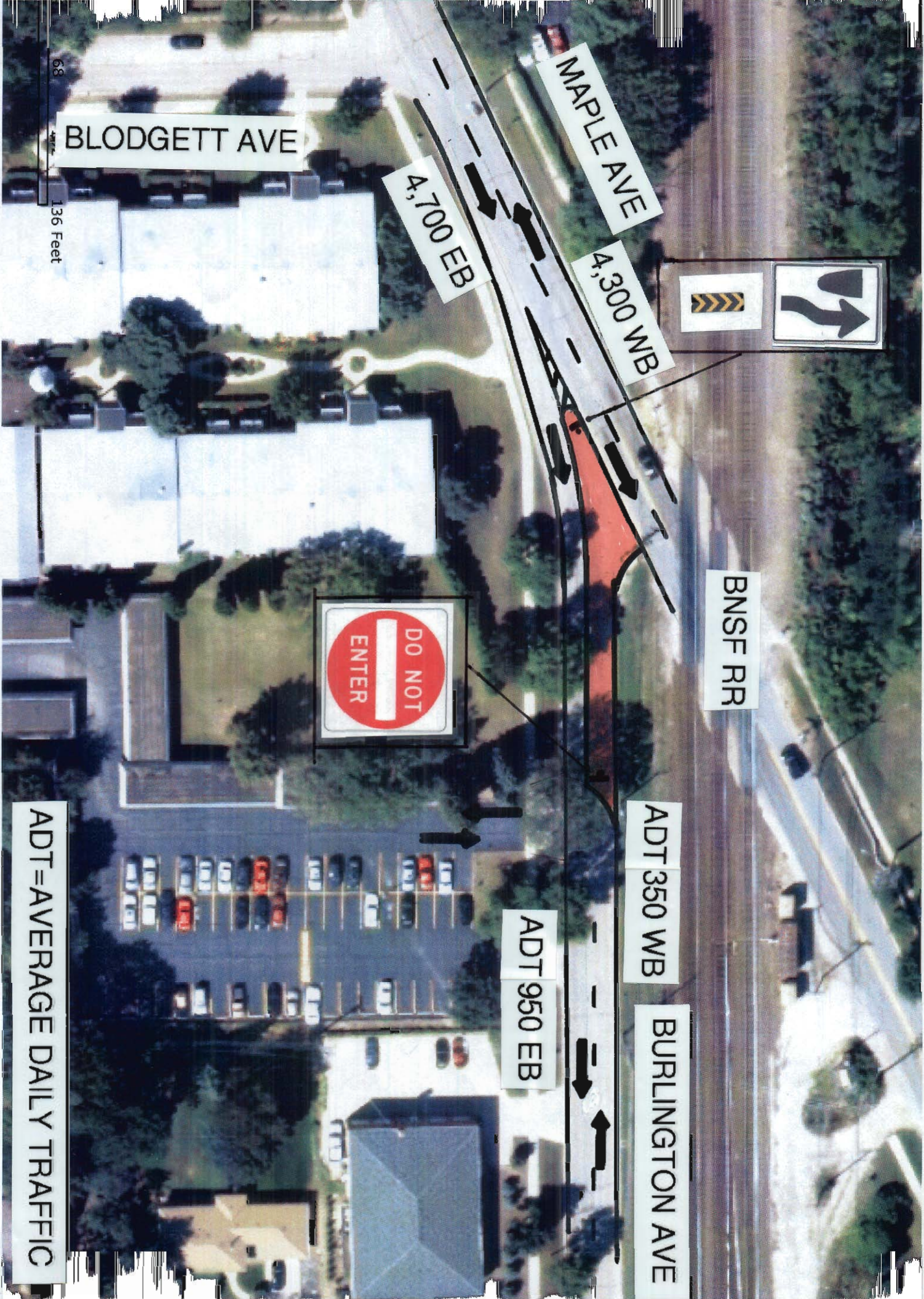
