SYNOPSIS

A motion is requested authorizing the Village's participation in the State of Illinois joint purchasing program for Verizon Wireless Internet Cards.

STRATEGIC PLAN ALIGNMENT

The Five Year Plan and Goals identified Exceptional Services and Communication.

FISCAL IMPACT

The FY10 budget includes \$52,620 in the General Fund for wireless internet card services. Annual costs under the State contract would amount to \$46,499.76 thus savings under the proposed agreement would be approximately \$6,120.

RECOMMENDATION

Approval on the July 6, 2010 consent agenda.

BACKGROUND

Currently, the Village utilizes a total of 102 Verizon wireless internet cards for public safety operations in the Police and Fire Departments. Utilizing these internal wireless internet cards, public safety personnel have the ability to remotely access programs on the Village's computer network such as the Computer Aided Dispatch (CAD) System as well as other reporting programs.

The current agreement with Verizon, Inc. was approved by the Village Council in March of 2009. Per the current agreement, the Village pays \$42.99 per month for each of its 102 Verizon wireless internet cards, for a total monthly cost of \$4,384.98. Participation through the joint purchasing program with the State of Illinois would reduce the monthly cost to \$37.99 per card, for a total monthly cost of \$3,874.98. Thus, approval of this motion will result in a monthly savings of \$510.00 for the Village (\$6,120 annually). The Village retains the right to cancel the service lines at any time without penalty.

This does not have any impact on the technical and operational aspects of the wireless connection for Village's public safety operations.
