SYNOPSIS

An ordinance has been prepared to amend sections of the Municipal Code to remove daytime parking restrictions on both sides of Cumnor Road, between Ogden Avenue and Grant Street.

UPDATE & RECOMMENDATION

This item was discussed at the October 12, 2010 Village Council meeting. Staff recommends approval on the October 19, 2010 active agenda.

BACKGROUND

Temporary daytime parking restrictions have been in place since 2008 on Cumnor Road between Ogden Avenue and Grant Street/Traube Avenue. The restrictions, which prohibit parking between 7:00 AM and 2:00 PM, except on Sundays and Holidays, were implemented to mitigate residents' concerns due to unloading of trailers and to eliminate the use of Cumnor Road for dealership parking.

Staff proposes to remove parking restrictions south of the SAAB dealership's driveway to the intersection of Grant Street and Cumnor Road. The temporary time period has expired for the parking restrictions and residents have requested that Cumnor Road be returned to the previous, unrestricted condition. Staff observed the Cumnor Road parking operation on several occasions this year. There have been no instances reported of dealer trailers loading or unloading of vehicles on Cumnor Road and staff has received no complaints regarding test driving of dealer vehicles along Cumnor Road.

Staff recommends maintaining the current parking restriction on Cumnor Road between Ogden Avenue and the Saab Dealer driveway. The restriction is needed in this area to maintain safe intersection turning movements from Ogden Avenue.

This item was presented at the September 8, 2010 Transportation and Parking Commission meeting with residents of this area in attendance. The Commission voted 5-2 to approve staff's proposed parking modifications. Two members that voted against the motion stating they wanted to see the remaining parking restriction extend further south to Morning Glory Circle.



TRANSPORTATION AND PARKING COMMISSION MEETING MINUTES

SEPTEMBER 8, 2010

1. File #17-10 Cumnor Road, Ogden Ave. to Grant Street - Parking Modifications. Traffic Manager Mr. Fera provided a slide of Cumnor Road on the overhead explaining that the street jurisdiction zigzags in the area but that all the parking signs belonged to the Village of Downers Grove. He recalled this matter was tabled because no one from the neighborhood was present at the last meeting. A history of the case followed. In bringing the matter up to date, Mr. Fera understood that the car dealerships have since moved out and those that have come in, the employees had found parking on the private side of the dealership. However, he stated the restrictions were still necessary from Ogden Avenue to the Saab Dealership's south driveway for safety purposes.

Mr. Stuebner referenced a letter received from three addresses on Cumnor Road and inquired as to how the letter spoke to the current situation since the Saab dealer now provided enough parking for its employees.

In response, **Ms. Connie Allen** explained that the Saab cars were still being unloaded on Cumnor Road, which they were not supposed to.

Dialog was raised on whether it would be a good idea to leave the restrictions in place south of the driveway near the condominiums; otherwise, if the restriction was lifted, there was concern that residents from the condos could begin parking there and/or possibly the dealer's employees.

Mr. Stanley Cole, responded by explaining that ample parking for the condos was provided.

Mr. Wendt believed this was an example of the economy and suggested removing the signs to see what occurs, but he surmised the issue would probably return a year from now.

MR. SARICKS MADE A MOTION THAT STAF REMOVE THE CURRENT PARKING RESTRICTIONS ALONG BOTH SIDES OF CUMNOR ROAD, BETWEEN THE SAAB DEALERSHIP DRIVEWAY, SOUTH TO TRAUBE AVENUE, ON CUMNOR ROAD. SECONDED BY MRS. VAN ANNE.

MOTION PASSED. VOTE: 5-2

Messrs. Cronin and Stuebner voted against the motion because they preferred what the two residents were proposing, i.e., that the restriction remain all the way to Morning Glory Circle thereby keeping the matter from returning to this Commission in the future.
