SYNOPSIS

A resolution has been prepared authorizing a 4 month extension (5/1/2011 thru August 31, 2011) of the contract with Claim Management Consultants to provide claim management services for workers compensation, general & auto liability.

STRATEGIC PLAN ALIGNMENT

The Village goals for 2011 include Exceptional Municipal Organization. A supporting objective is Financially sound and sustainable Village government.

FISCAL IMPACT

The current monthly fee is \$4,200. The four month total would be \$16,800. The FY11 budget includes \$47,000 in the Risk Management Fund for claims administration services.

RECOMMENDATION

Approval on the April 12, 2011 Consent Agenda

BACKGROUND

The Village published an RFP for third party claims administration services on 2/11/2011. Four companies submitted proposals in response to the RFP. To allow time to thoroughly evaluate those companies, staff is requesting an extension of the existing third party claims administration contract with Claims Management Consultants. Claims Management Consultants has agreed to extend the current contract at the existing fee for an additional four months.
