Municipal Aggregation

- Passed referendum on March 20 allowing Village to arrange for electricity supply
- ComEd still distributes electricity
- Supply rate will be lower than ComEd
- Any customer can opt-out

Aggregation Process

Step #1: Referendum on March 20 Ballot

Step #2: Ordinance Adopting Plan of Governance and Authorizing Aggregation

Step #3: Competitive RFP process

- Open to any of the 23 suppliers that meet requirements of Plan



Step #4: Opt-out Process

Plan of Operation and Governance



Summary

- Covers the following major points:
 - Describes RFP Procedures
 - Lists eligible categories of customers
 - Sets requirements for eligible suppliers and maintains ability to terminate contract
 - Dictates how new customers will be included
 - Provides for opt-out process



Key Points

- Contract Process: RFP
- Eligible Suppliers:
 - Certified to Provide Residential Service
 - -Agree to All Requirements
- Initial Contract: One year, with option to renew
 - Opt-out Process: At least two weeks

Key Points, continued

- Ineligible Resident Groups:
 - Under existing supply contract
 - Space heat customers
 - Hourly (real-time) pricing
 - Free service or bundled hold
- Eligible Businesses:
 - Using less than 15,000 kwh per year



Key Points, continued

Renewable Energy:

Increments ranging from staterequired to 100%

- Opt-Out: Conducted by Supplier
- Opt-Out Regret Period: Period of 60 days to re-enroll in program



Key Points, continued

- New Members: Same terms, if located where an account existed
- Moving Accounts: Same terms if moving within Village
- Early Termination: Fee may be assessed

Aggregation Process

Partnership Opportunity

- Proposal to Partner with Village of Westmont
- IGA Allows for Joint RFP and Contracting Process
- Allows for Economy of Scale and Access to Consultant
- Consultant at Cost of \$10,000



Aggregation Process

Request for Proposals

- Seek qualifications and proposals from electrical suppliers for pre-approval
- Proposals to include preliminary pricing, including pricing for renewable energy
- Council will review and approve qualified suppliers
- Village Manager will authorize contract for lowest rate from qualified suppliers
