2012 New Sidewalk Installation Program

<u>Work Performed This Week:</u> Completed restoration of all asphalt driveways. All new sidewalks were completed and opened to pedestrian traffic by the start of school on 8/27/12. Continued watering operations of previously installed sod.

<u>Work Anticipated Next Week:</u> Resume installation and watering of sod on Sterling, Carol, Virginia, Brook and Downers as soon as the weather gets cooler.

2012 Replacement Sidewalk Program

Awarded Amount: \$130,522.50 Start of construction: July 9th

Contract Completion date: August 7th

This week the Contractor finished all restoration work involving dirt & seeding in grassed areas, and patching

asphalt driveways. All work except punchlist items has been completed.

Maple Avenue Water Tower Repainting Project

Awarded Amount: \$954,210

Contract Completion Date: November 26, 2012

Work Performed This Week:

• Began sandblasting of interior flute.

Work Anticipated Next Week:

- Continue sandblasting of interior flute.
- Begin sandblasting exterior flute.

Completion of this project was delayed as a result of the unprecedented drought and higher than average daily water use. A notice to proceed was issued to the contractor August 7. The tank has been isolated from the water distribution system, and will be drained by September 4. The contractor has been working diligently toward completion.

2012 Water Main Improvements – Contract A

Contract Amount: \$1,062,737.50 Contract Completion Date: 9/14/12

Work Performed This Week:

The contractor installed erosion control on Lee Ave and Cross St as needed. ComEd braced a utility pole on 38th St so water main installation can begin next week.

Work Anticipated Next Week:

Aggregate shoulder installation on 40th St, begin water main improvements on 38th Street, begin sod preparation and site restoration of disturbed areas.

2012 Water Main Improvements - Contract B

Awarded Amount: \$1,312,022.56

Contract Completion date: September 28th

<u>Work Performed This Week:</u> This week the water main on Blodgett Avenue between Maple Avenue and Randall Street was completed. Pressure testing and chlorination of the Blodgett Avenue and Cumnor Road water main will follow.

<u>Work Anticipated Next Week:</u> Next week the water main installation will start on Curtiss Street between Belmont Road and Katrine Avenue. The Contractor remains approximately 2 weeks behind the approved construction schedule and has been directed to submit a new schedule indicating completion of the remaining work. The schedule has yet to be submitted.

STORMWATER/DRAINAGE IMPROVEMENTS

2nd and Cumnor – Basin Planting

Contract Amount: \$39,515.00

The grading and plantings are complete. The contractor is continuing with maintenance and monitoring of the plants. Maintenance includes management of the weeds that typically grow until the planted materials are established.

Begin design after determination of the weir structure by the Illinois Department of Natural Resources. Staff is coordinating with the contractor to schedule a public meeting for design comments in late September.

Lacey Creek (Sub G) Stormwater Improvements - 35th St between Saratoga and Venard

Final plans and specifications have been delivered and the project permit was approved by the Army Corp of Engineers. Project will be constructed in spring 2013.
