SYNOPSIS

A resolution has been prepared to authorize approval for a contract extension with Shane's Office Supplies for the purchase of office supplies. Extension of this contract will maintain the same office supply prices as provided for in the existing contract with Shane's Office Supplies.

FISCAL IMPACT

The FY13 budget includes \$83,000 in the General Fund for the purchase of office supplies.

BACKGROUND

The office supply contract was competitively bid in fiscal year 2012, and Shane's Office Supplies was approved as the low bidder. The Village entered into a one-year contract with the option for two one-year extensions. Shane's has provided excellent customer service; orders are placed on line with next day free delivery for all in stock items. This agreement does not require the Village to purchase from Shane's exclusively and staff will continue to have the ability to use other vendors in emergency situations.
