SYNOPSIS

A resolution has been prepared authorizing the Village's submittal of application to the DuPage Mayors & Managers Conference (DMMC) for the 2014 Surface Transportation Program (STP) for highway project funding. This application is due to DMMC on or before August 9, 2013.

STRATEGIC PLAN ALIGNMENT

The Goals for 2011 to 2018 identified Top Quality Infrastructure.

FISCAL IMPACT

If the Village receives grant funding for the identified project, Village staff will prepare engineering plans and construction documents. The Village's cost share is 30% of the total construction cost.

RECOMMENDATION

Approval on the July 16, 2013 consent agenda.

BACKGROUND

The STP program provides funding for highway construction projects and is administered by the DuPage Mayors and Managers Conference. Projects that are submitted for the STP Program are required to meet specific threshold criteria, and are reviewed and ranked with other submitted projects throughout the County. Staff is preparing an application for the resurfacing of Main Street, from Franklin Street to Ogden Avenue, which is likely to receive a favorable ranking in the program based on traffic levels. If approved, the Village's cost for the project would be 30% of the total project cost. The project would be constructed in 2019.

In the past the Village has successfully received funding from this program for projects such as the traffic signal replacement at Main and Grant, Carpenter Street from Gilbert to Maple, and several others, including two projects that received funding last year for the 2013 to 2018 program.
