**SYNOPSIS**

An ordinance has been prepared to amend a section of the Municipal Code concerning the installation of one 15-Minute parking space, along the south side of Burlington Avenue west of Main Street.

**BACKGROUND**

The request to provide one additional short-term parking space on the west side of Main Street to serve the US Bank, Caribou Coffee and other area businesses was brought forward by the Downtown Management Corporation. These businesses experience a high level of parking turnover and would benefit from the addition of a 15-minute parking space.

In 2011, the Village adopted the Downtown Parking Study. To address the needs of businesses with a high number of short customer transactions, the Study recommended that one 15-minute parking space be provided on the blocks with these types of businesses. Thirteen (13) of these spaces have been designated throughout the downtown area since the adoption of the study. This block of Burlington Avenue does not currently include a 15-minute space.

Burlington Avenue is one-way westbound in this area. There are currently twelve diagonal (2-Hour) parking spaces along the south side, from Main Street to the Forest Lot South (Library) driveway. Three (3) parallel spaces extend from the driveway west to Forest Avenue. Forest Lot North is located along the north side of Burlington Avenue. Both Forest Lots are designated as 3-Hour parking, which provide limited service to short-term customers. It is expected that with one short-term space, the parking needs will be better served at this location.

This item was presented to the Transportation and Parking Commission on June 19, 2013. The Commission voted unanimously to approve this action as presented.

**AN ORDINANCE ESTABLISHING A  
FIFTEEN MINUTE PARKING ZONE ON BURLINGTON AVENUE**

BE IT ORDAINED by the Village Council of the Village of Downers Grove in DuPage County, Illinois, as follows: (Additions are indicated by ~~shading~~/underline; deletions by ~~strikeout~~):

**Section 1. That Section 14.108.6. is hereby amended to read as follows:**

**14.108.6. Fifteen minute parking.**

(a) It shall be unlawful to park or let stand any vehicle for more than fifteen consecutive minutes on a daily basis in the following locations:

- (1) The north side of Curtiss Street from a point forty feet west of the west line of Washington Street to a point one hundred eighteen feet west of such west line.
- (2) The two spaces (by disabled parking) in south corner of the Library Lot.
- (3) The south side of 935 Burlington Avenue.
- (4) The south side of 937 Curtiss Avenue.
- (5) The south side of 1001 Curtiss Avenue
- (6) The north side of 1028 Curtiss Avenue.
- (7) The east side of 4947 Main Street.
- (8) The east side of 5002 Main Street.
- (9) The west side of 5006 Main Street.
- (10) The east side of 5115 Main Street.
- (11) The west side of 5122 Main Street.
- (12) The east side of 5157 Main Street.
- (13) The north side of 940 Warren Avenue.

(b) It shall be unlawful to park or let stand any vehicle for more than fifteen consecutive minutes between 6:00 a.m. and 6:00 p.m., Monday through Friday in the following locations:

- (1) The south side of Burlington Avenue, from a point fifty (50) feet west of the west line of Main Street, to a point sixty (60) feet west of the west line of Main Street.

**Section 2.** That all ordinances or parts of ordinances in conflict with the provisions of this ordinance are hereby repealed.

**Section 3.** That this ordinance shall be in full force and effect from and after its passage and publication in the manner provided by law.
