**SYNOPSIS**

An ordinance proposing the establishment of a SSA for fire protection services has been prepared.

**UPDATE & RECOMMENDATION**

This item was discussed at the August 6, 2013 Village Council meeting. Staff recommends approval on the August 13, 2013 Active Agenda.

**BACKGROUND**

The Village is proposing establishment of a Special Service Area (SSA) #6 for certain unincorporated properties located in and adjacent to the Fairview Fire Protection District through which property owners will pay the full cost of providing fire and emergency medical services.

The Village has provided fire and emergency medical services to the unincorporated area near 39<sup>th</sup> Street and Fairview Avenue for several decades. A portion of this area is part of the Fairview Fire Protection District; other properties not in the district are billed directly for the services. For the last several years, the FFPD has been unable to pay the Village for the full costs of providing these services, resulting in a total unpaid balance of more than \$100,000. The Village and Fairview Fire Protection District, working with DuPage County, have identified the creation of a special taxing district to provide a sustainable funding source for this service. The property tax levied in the SSA will be an amount needed to pay the full cost of providing the services. Upon establishment of the SSA, the Village will forgive the District's outstanding deficit.

The SSA would include 249 properties. The Village proposes a maximum annual rate not to exceed 5% of each property's Equalized Assessed Value (EAV) as a tax levy.

The proposed ordinance is a requirement of the SSA establishment process. After a 60-day period, the Village is required to hold a public hearing. Notice of the public hearing will be published in the Downers Grove Reporter and mailed to the affected property owners as required by state statute. Following a 60 day objection period, an ordinance approving the establishment of the SSA will be placed on a Council agenda.

**ORDINANCE NO. \_\_\_\_\_**

**AN ORDINANCE PROPOSING THE ESTABLISHMENT OF  
SPECIAL SERVICE AREA NUMBER 6  
IN THE VILLAGE OF DOWNERS GROVE, ILLINOIS AND  
PROVIDING FOR A PUBLIC HEARING  
AND OTHER PROCEDURES IN CONNECTION THEREWITH**

WHEREAS, certain portions of unincorporated DuPage County (“County”) located near the Village of Downers Grove (“Village”), which are both within and outside of the boundaries of the Fairview Fire Protection District (“District”), have their fire protection and emergency medical services (“fire protection services”) provided by the Village; and

WHEREAS, the District is unable to obtain or deliver adequate fire protection services to its residents; and

WHEREAS, it is in the best interests of the County, the District, and the Village, that the Village provide enhanced fire protection services to the areas set forth in Section 4 of this Ordinance, including territory within the Village, as well as territory in the unincorporated area of the County; and

WHEREAS, the Special Service Area Tax Law provides that a municipality may create a Special Service Area within a municipality and the unincorporated area of a county when the county consents to the creation of the Special Service Area, 35 ILCS 200/27-5; and

WHEREAS, the Village requested that the County provide its consent to the creation of a Special Service Area, within the legal boundaries set forth in Section 4 below that represent the portions of unincorporated DuPage County, located adjacent to the Village, which currently receive fire protection services from the Village; and

WHEREAS, the County approved Resolution 0049-13 on July 9, 2013, wherein it provided consent to the establishment of a Special Service Area by the Village.

NOW, THEREFORE BE IT ORDAINED by the Council of the Village of Downers Grove, DuPage County, Illinois, as follows:

**Section 1. Authority to Establish Special Service Area.**

Special Service Areas are established pursuant to Article VII, Section 6L of the Constitution of the State of Illinois in force July 1, 1971, which provides:

The General Assembly may not deny or limit the power of home rule units (1) to make local improvement by special assessment and to exercise this power jointly with other counties and municipalities, and other classes of

units of local government having that power on the effective date of this Constitution, unless that power is subsequently denied by law to any such other local unit of government, or (2) to levy or impose additional taxes upon areas within their boundaries in the manner provided by law for the provision of special services to those areas and for the payment of debt incurred in order to provide those special services and are established pursuant to the provision of an Act to provide the manner of levying or imposing taxes for the provision of special services to areas within the boundaries of home rule units and non-home rule municipalities and counties pursuant to the Revenue Act of 1939.

**Section 2.** Findings. The Village Council finds:

- A. It is in the public interest that the creation of the area hereinafter described as a special service area for the purposes set forth herein be considered.
- B. That said area is compact and contiguous and constitutes the sole area to be benefitted from the operation of said services.
- C. That said area is zoned for residential purposes and will benefit specially from the municipal services to be provided and that the proposed services to be provided by the Village of Downers Grove are services not currently provided to the residents within said area, and it is, therefore, in the best interest of the Village of Downers Grove and those residents within said area that the levy of special taxes against said area for the services to be provided be considered.

**Section 3.** Public Hearing – Tax Rates.

That a public hearing be held on October 15, 2013 at 7:00 p.m. in the Council Chambers of the Civic Center, 801 Burlington Avenue, Downers Grove, Illinois, to consider the creation of Special Service Area Number 6 of the Village of Downers Grove, in the territory described in the Notice set forth in Section 4 hereof. At the hearing, there will be considered the levy of an annual tax not to exceed an annual rate of five percent (5%) of the assessed value, as equalized, of the property in the Special Service Area. Said taxes shall be in addition to all other taxes provided by law and shall be levied pursuant to the provisions of the Revenue Act of 1939. The Village may annually levy hereunder up to the maximum rate specified herein for the cost of said services.

**Section 4.** Notice of Hearing.

Notice of hearing shall be published at least once not less than fifteen (15) days prior to the public hearing in one or more newspapers in general circulation in the Village of Downers Grove. In addition, notice by mailing shall be given by depositing said notice in the U.S. Mail addressed to the person or persons in whose name the general taxes for the preceding year were paid on each lot, block, tract, or parcel of land lying within the proposed Special Service Area. Said notices shall be mailed not less than ten (10) days

prior to the time set for the public hearing. In the event the taxes for last preceding year were not paid, the Notice shall be sent to the person last listed on the tax rolls prior to that year as the owner of the property. The Notice shall be in substantially the following form:

THAT PART OF THE PARCELS LISTED BELOW THAT ARE PART OF THE SOUTHEAST ¼ OF SECTION 32 ALONG WITH THE SOUTHWEST ¼ OF SECTION 33 IN YORK TOWNSHIP (TOWNSHIP 39 NORTH, RANGE 11 EAST OF THE THIRD PRINCIPAL MERIDIAN) ALSO THAT PART OF THE PARCELS LISTED BELOW THAT ARE PART OF THE NORTHWEST ¼ OF SECTION 4 IN DOWNERS GROVE TOWNSHIP NORTH. An accurate map of said territory is on file in the office of the Village Clerk and is available for public inspection.

All interested persons affected by the formation of Downers Grove Special Service Area Number 6, including all persons owning taxable real property within said special service area, will be given the opportunity to be heard regarding the formation and boundaries of the area and may object to the formation of the area and the levy of taxes affecting said area. The hearing may be adjourned by the Council to another date without further notice other than a Motion to be entered upon the minutes of its meeting fixing the time and place of its adjournment.

The purpose of the formation of Downers Grove Special Service Area Number 6 in general is to provide special municipal services to the area, including, but not limited to, fire protection services.

A special tax will be considered at the public hearing to be levied in an amount not to exceed an annual rate of five percent (5%) of the assessed value, as equalized to be levied against the real property included in the special service area. This tax may be levied for an indefinite period of time during and in the years subsequent to the date of this Ordinance.

If a petition signed by at least fifty-one percent (51%) of the electors residing within the special service area and by at least fifty-one percent (51%) of the owners of record of the land included within the boundaries of the Special Service Area is filed with the Village clerk within sixty (60) days following the final adjournment of the public hearing objecting to the creation of the special service district, the enlargement thereof, the levy or imposition of a tax for the provision of special services to the area, or to a proposed increase in the tax, no such district shall be created or enlarged, or tax may be levied or imposed nor the rate increased.
