BACKGROUND

Little Friends, Inc. is a not-for-profit organization supporting persons with Autism and other developmental disabilities. Under the name of Spectrum Vocational, they provide developmental training program services from a building at 2302 Wisconsin Avenue in Downers Grove. They intend to remodel this facility, by providing lighting upgrades, a new HVAC system and new loading dock overhead doors and equipment.

Section 1-29 of the Municipal Code allows the Village Council to waive certain fees, including building permit fees in accordance with Council Policy 96-44. Per the policy, a fee waiver request greater than \$5,000 requires approval by the Village Council. Little Friends, Inc., is an eligible not-for-profit organization and is requesting relief from the cost of their building permit which will be \$6,487.00. Staff has reviewed the request and believes it is consistent with the policy and past practice, and recommends relief from the building permit fees in the amount requested.

I am writing today to request a waiver of building permit fees associated with a remodeling project we will be undertaking here at Spectrum Vocational, 2302 Wisconsin Avenue, Downers Grove, in our Developmental Training Program.

Little Friends Inc/Spectrum Vocational is a non-profit supporting persons with Autism and other developmental disabilities to live, learn and work in the community. Spectrum is the Adult Day Services Division providing work opportunities through our Supported Employment Program and Developmental Training-Work Services Program here in Downers Grove. The remodeling is being funded mostly by a DuPage County Community Development Block Grant-Disabilities Needs Cluster Grant. Little Friends will need to pay any money over the \$176,490 granted (about \$19,610 more, we're guessing) which is a substantial amount for a social service agency to spend.
