BACKGROUND

The Downers Grove Public Library has applied for a building permit fee waiver in the amount of \$14,755.00. Section 1-29 of the Downers Grove Municipal Code allows the Village Council to waive certain fees at its discretion in conjunction with Council Policy 96-44. Where the fee waiver request exceeds \$5,000.00, Village Council approval is required. Staff finds that the Downers Grove Public Library is an entity eligible to apply for the waiver. The work involves an interior renovation with additional mechanical and electrical improvements.
