#### **SYNOPSIS**

The FY15 Municipal Budget will provide for all operational revenues and expenditures for the time period from January 1, 2015 through December 31, 2015.

#### **UPDATE & RECOMMENDATION**

This item was discussed at the Saturday Budget Workshop on October 11, the Village Council meetings on October 14 and 21, and Coffee with the Council on October 18. The Village held the required public hearing on November 4, 2014. Staff recommends approval on the November 11, 2014 Active Agenda.

On September 26, 2014, the proposed FY15 Municipal Budget was published for the Village Council and the public. ### AN ORDINANCE ADOPTING THE FISCAL YEAR 2015 BUDGET IN LIEU OF PASSAGE OF AN APPROPRIATION ORDINANCE

WHEREAS, the Village Council of the Village of Downers Grove has provided for the preparation and adoption of an annual budget in lieu of passage of an appropriation ordinance for the fiscal year 2015; and

WHEREAS, a proposed annual budget has been prepared, published by the Village Council and made available for inspection for at least ten days, all as provided by law; and

WHEREAS, notice has been given and a public hearing held on November 4, 2014, as provided by law; and

WHEREAS, the Village Council of the Village of Downers Grove has examined said annual budget and has heard all persons appearing and desiring to be heard concerning said annual budget,

NOW, THEREFORE, BE IT ORDAINED by the Council of the Village of Downers Grove, in DuPage County, Illinois, as follows:
