Follow-Up on Duration of Power Outages - At the December 16 Village Council meeting, Commissioner Barnett asked for additional information on the improvement in the duration of electricity outages. The outage data shows that weather and tree-related issues cause the outages of the longest duration and most occur around major storms during summer months. In 2014 (through 10/31), a mild

weather year, there were fewer outages over 4 hours and fewer outages longer than 24 hours. ComEd also completed equipment upgrades and tree trimming intended to reduce the risk of weather-related outages throughout 2013 and 2014, but given the mild weather, it's difficult to determine whether these upgrades contributed to the improvement. Staff will continue to review outage data to see if the duration of outages continues to trend downward.

Chart: Outages Four Hours or Longer (1/1/2007 - 10/31/2014)



Chart: Outages 24 Hours or Longer (1/1/2007 - 10/31/2014)


