SYNOPSIS

A resolution has been prepared to authorize a three-year contract extension effective July 1, 2015 with Horton Group of Orland Park, IL for Plan Consulting Services for an amount not to exceed \$38,700 annually.

STRATEGIC PLAN ALIGNMENT

The goals for 2011-2018 includes Steward of Financial and Environmental Sustainability.

FISCAL IMPACT

The FY15 Municipal Budget provides \$38,700 for this annual cost within the Health Insurance Fund. The proposed contract price of \$38,700 stays within budget and reflects no increase in cost for the service.

RECOMMENDATION

Approval on the February 17, 2015 Consent Agenda.

BACKGROUND

In 2012, the Village received proposals from companies to provide employee benefits consulting services. After interviewing several providers, the Village entered into a three-year contract with The Horton Group. Since then the Horton Group has provided the following services: conducted research and advised the Village on healthcare reform requirements, screened health benefits products and negotiated various insurance products and alternatives. The Horton Group has provided excellent services including protecting the Village from the looming Cadillac Tax through the Affordable Care Act. The Horton Group and staff have worked closely over the past three years and staff has been pleased with the services they have provided. Therefore, staff is recommending approval of an extension to the contract through June 30, 2018.
