SYNOPSIS

A resolution has been prepared authorizing a three-month extension of a contract for ordinance violation prosecution services with Linda S. Pieczynski, Attorney at Law, P.C. for a flat fee of \$2,916.67 per month.

STRATEGIC PLAN ALIGNMENT

The Village goals for 2011-2018 include Exceptional Municipal Services.

FISCAL IMPACT

The FY15 budget includes funding for this service in the General Fund. The flat fee for prosecution of ordinance violations is \$2,916.67 per month.

RECOMMENDATION

Approval on the February 17, 2015 consent agenda.

BACKGROUND

In January, 2010, the Village issued a Request for Proposal (RFP) for prosecution services and entered into an agreement with Linda S. Pieczynski, Attorney at Law, P.C. to represent the Village in ordinance violation cases. In 2013, the agreement was extended for two additional years. The current agreement is set to expire February 28, 2015.

Ms. Pieczynski has recently informed the Village of her plans to retire on June 1, 2015. In light of this, staff is recommending extending the current agreement for an additional three (3) months (until May 31, 2015) at no increase in cost. During such time, staff intends on issuing a Request for Proposal for prosecution services.

EXTENSION TO THE AGREEMENT FOR PROSECUTION SERVICES BETWEEN THE VILLAGE OF DOWNERS GROVE AND LINDA S. PIECZYNSKI

The Village of Downers Grove, Illinois (the "Village") and Linda S. Pieczynski, Attorney at Law, P.C., entered into an Agreement for ordinance violation prosecution legal services on or about February 9, 2010. Pursuant to the terms stated therein, the parties desire to extend that contract for a two-year period under the following terms:

- 1. That Section 2 of the 2010 Agreement (Compensation) shall be revised as follows: The Village shall pay Linda S. Pieczynski, Attorney at Law, P.C., a flat fee of \$2,916.67 per month. Commencing March 1st and ending May 31st, 2015. That this fee shall include compensation for in-court time, preparation, travel time, attendance at meetings with Village staff, telephone conferences, and any and all administrative costs in connection with prosecuting ordinance violation cases. This does not include training.
- 2. All terms from the 2010 Agreement remain in full force and effect.
- 3. This extension shall continue for a three-month period ending May 31, 2015, 2015.
