**SYNOPSIS**

A resolution has been prepared to authorize a contract extension with Marcott Enterprises, Inc of Elmhurst, Illinois until December 31, 2015 for the provision of debris hauling services. There is no change in contract cost for this time extension for a contract total not to exceed \$86,700.

**STRATEGIC PLAN ALIGNMENT**

The goals for 2011-2018 identified *Top Quality Infrastructure*.

**FISCAL IMPACT**

The FY15 Budget includes a total of \$131,400 for debris hauling (\$71,400 in the Stormwater Fund and \$60,000 in the Water Fund).

**RECOMMENDATION**

Approval on the February 17, 2015 consent agenda.

**BACKGROUND**

The contract amount is based on the hauling and disposal of approximately 285 loads of debris required for Public Works street, stormwater and water utility system maintenance. The vendor has agreed to extend the contract until December 31, 2015 at the current price.

3. That the proper officials, agents and employees of the Village are hereby authorized and directed to take such further action as they may deem necessary or appropriate to perform all obligations and commitments of the Village in accordance with the provisions of the Agreement.

4. That all resolutions or parts of resolutions in conflict with the provisions of this Resolution are hereby repealed.

5. That this Resolution shall be in full force and effect from and after its passage as provided by law.

MARCOTT ENTERPRISES, INC.**



1. This is the second of two optional extensions and the contract shall be extended through December 31, 2015.
2. The Provider agrees to provide the products and services at the same rate as listed in the first contract extension in 2014 for a total not-to-exceed price of \$86,700.
3. All other terms from the April 15, 2013 contract remain in full force and effect.
