SYNOPSIS

A resolution has been prepared stating the Village's intent to issue General Obligation bonds for water system improvements. Adoption of the resolution is required for the Village to allow project expenditures from the proceeds of a tax-exempt bond to be reimbursed.

STRATEGIC PLAN ALIGNMENT

The goals for 2011-2018 include Steward of Financial and Environmental Sustainability and Top Quality Infrastructure.

FISCAL IMPACT

Upon issuance of a general obligation bond, the Village may utilize bond proceeds for expenses related to the water system improvements that were incurred within sixty (60) days prior to the passage of this resolution

RECOMMENDATION

Approval on the February 17, 2015 Consent Agenda.

BACKGROUND

Pursuant to the Long Range Plan and the FY15 budget, the Village will be issuing bonds to pay for needed improvements to the water system. The 2015 bond issuance will total \$5 million which will be used for watermain replacements and other water system improvements. The debt service payments on the bonds will be made using revenues from the water rates. This bond issuance is consistent with the 2010 Water Rate Study, the Long Range Plan and the FY15 budget.

The reimbursement resolution will allow the Village to use the bond proceeds for costs incurred on any projects prior to the receipt of the bond proceeds. Approval of the resolution will allow the Village to apply the proceeds to these costs. An ordinance for the issuance of the general obligation bonds will be presented to the Village Council for approval in March.

DECLARATION OF OFFICIAL INTENT TO REIMBURSE EXPENDITURES

A RESOLUTION declaring the official intent to reimburse expenditures for the certain capital expenditures of the Village with the issuance of not to exceed \$5,000,000 General Obligation Bonds, Series 2015, of the Village of Downers Grove, DuPage County, Illinois.

WHEREAS, pursuant to the provisions of Section 6 of Article VII of the Constitution of the State of Illinois the Village of Downers Grove, DuPage County, Illinois (the "Village"), is a home rule unit and may exercise any power or perform any function pertaining to its government and affairs including, but not limited to, the power to tax and to incur debt; and

WHEREAS, The Village intends to construct, renovate, equip, rehabilitate and/or improve certain infrastructure within the Village, including, but not limited to, certain infrastructure projects related to the Village's Waterworks System (collectively, the "*Project*"); and

WHEREAS, the Village reasonably expects to advance its own funds to pay certain costs of the Project and subsequently reimburse these advances with proceeds of debt to be incurred by the Village; and

WHEREAS, the Village expects to issue debt in one or more series not expected to exceed \$5,000,000 in aggregate principal amount, plus costs of issuance, for purposes of financing, refinancing or reimbursing costs of the Project;

NOW, THEREFORE, BE IT RESOLVED that the Village declares its official intent to construct, renovate, equip, rehabilitate and/or improve the Project; to reimburse certain costs of constructing, renovating, equipping, rehabilitating and/or improving the Project with proceeds of debt to be incurred by the Village; and to issue debt in one or more series not expected to exceed

\$5,000,000 in aggregate principal amount, plus costs of issuance, for purposes of financing, refinancing or reimbursing costs of the Project.

NOW, THEREFORE, BE IT RESOLVED that the Village intends this resolution to satisfy the requirements of the Internal Revenue Code of 1986, as amended and the regulations promulgated thereunder (the "Code"), and specifically Treasury Reg. §1.150-2(d), regarding the declaration by the Village of its official intent to issue its bonds for the purpose of reimbursing original expenditures (as that term is defined in Treasury Reg. §1.150-2(c)) incurred with respect to the Project within 60 days preceding the adoption of this resolution.
