#### SYNOPSIS

A resolution is requested to authorize an amendment to an existing contract with Christopher B. Burke Engineering, Ltd. (CBBEL) of Rosemont, Illinois, for design engineering services for the Clyde Estates Improvements in the amount of \$11,000.00.

#### STRATEGIC PLAN ALIGNMENT

The goals for 2011 to 2018 identified Top Quality Infrastructure.

#### **UPDATE & RECOMMENDATION**

This item was discussed at the March 3, 2015 Village Council meeting. Based on Council direction, staff is presenting a new change order request that also removes sidewalks from the project. The amount of the proposed change order is \$14,750 for a new total not-to-exceed cost of \$113,017.40.

Staff recommends approval on the March 10, 2015 agenda.

#### **BACKGROUND**

On April 8, 2014, the Council approved a contract with Christopher B. Burke Engineering, Ltd. (CBBEL) of Rosemont, Illinois in the amount of \$98,267.40 for the design of improvements for Clyde Estates. The scope of the project included roadway reconstruction throughout the subdivision, stormwater improvements, and the design of new sidewalks throughout the subdivision.

Engineering plans are approximately 90% complete. Based on public input that has been provided a revised scope of work has been prepared which includes:

- Elimination of the traffic circle and revision of the grading at the intersection of Washington/Webster/60th Place,
- Raising ditch profiles and addressing water main cover issues, and
- Revision of resulting stormwater calculations and plan quantities.

Staff has reviewed the attached change order prepared by Christopher B. Burke Engineering Ltd., in response to the proposed change in project scope and recommends its approval. With an advertisement for bids in mid-April it is anticipated that a recommendation for award of bid for construction will be presented to Council in early June for a project completion by November 2015.

Dear Mr. Sikich:

Christopher B. Burke Engineering, Ltd. is in receipt of additional comments issued by the Village based on final plans submitted by our office on January 12, 2015. The final plans were designed based on accepted design criteria and direction provided by the Village. We are requesting additional fee for efforts associated with the redesign of the ditches, culverts and traffic circle. The summary below details the anticipated costs associated with the redesign:

1. Eliminate traffic circle and revise intersection at Washington/Webster/60<sup>th</sup> Place: Roadway Geometry and Cross Sections = 16 hours

Drainage = 8 hour

2. Raising ditch profiles and addressing water main cover issues

Ditch Profiles = 16 hours Water Main = 4 hours

3. Various Plan Changes

Pipe material changes, update pipe schedule, add utility crossing information, show all house addresses, update summary of quantities = 10 hours

- 4. Revise stormwater calculations and permit submittal = 24 hours
- 5. Quantities Changes = 6 hours
- 6. Update Specifications = 4 hours

It is also understood based on our phone conversation that the Village would like to have the proposed sidewalks eliminated from the design plans throughout the Clyde Estates

subdivision. This work will include removing the sidewalks, adjusting our ditch profiles and alignments, shifting storm sewers and driveway culverts, analyzing whether sections of storm sewer are still required and amending the stormwater permit calculations.

1. Remove Sidewalks = 30 hours

Our proposal to address the additional comments (118 hours) is \$14,750.

We are prepared to complete the plans, specifications and estimates in accordance with your schedule upon approval of this supplemental proposal.
