#### **S**YNOPSIS

A resolution has been prepared to authorize a contract extension with 3M Company of St. Paul, MN until December 31, 2015 for traffic sign materials for a total not-to-exceed amount of \$20,000.

#### BACKGROUND

Traffic sign materials covered by this contract include the retro-reflective plastic sheeting used to fabricate new and replacement signs.

Per Village purchasing regulations, staff issued a Request for Bids and received five responses meeting specifications as summarized below.
