SYNOPSIS

A resolution has been prepared to authorize an amendment to an existing contract for professional services for Draintile Investigations to Hey and Associates, Inc. of Volo, Illinois. This amendment will increase the total not-to-exceed amount to \$36,360 with an additional \$18,180.00.

STRATEGIC PLAN ALIGNMENT

The Goals for 2011 to 2018 identified *Top Quality Infrastructure*.

FISCAL IMPACT

The FY15 budget includes \$25,000 for draintile investigation services.

RECOMMENDATION

Approval on the April 14, 2015 consent agenda.

BACKGROUND

Some areas in the Village developed prior to the era of storm sewers and are drained by clay drain tiles. Due to their age many of these drain tiles are in poor condition, which has led to poor drainage. The scope of this proposed work includes investigating existing draintiles and storm sewers at various locations on public and private property.

The Village entered into an agreement with Hey and Associates, Inc. in 2011 for draintile investigations. The Village has approximately \$3,500 left on the original contract and the amendment will allow additional services under the existing contract.

The firm is highly qualified to perform the professional services required for the Draintile Investigation Services project. Hey and Associates, Inc. has also performed draintile investigations for the communities of Wildwood, Barrington, Woodstock, and for Lake County and the Illinois Department of Transportation. Hey and Associates, Inc. has also successfully completed stormwater design for the Village for the Wisconsin and Janes Watershed Improvement Project (SW-062).
