SYNOPSIS

A resolution has been prepared authorizing execution of 12-month license agreement renewal with SADA Systems, Inc. of North Hollywood, CA, for use of Google Apps for Government in the amount of \$25,200.

STRATEGIC PLAN ALIGNMENT

The goals for 2011-2018 include *Continual Innovation*.

FISCAL IMPACT

The FY15 General Fund Budget includes \$25,200 for this renewal.

RECOMMENDATION

Staff recommends approval to renew Google Apps for Government with SADA Systems Inc. in the amount of \$25,200.

BACKGROUND

The Village has used Google Apps for Government since 2012. Village staff has benefited from the following areas:

- Improved search capabilities, especially for email searches in response to Freedom of Information Act (FOIA) requests
- Reduced costs associated with hardware, software and labor.
- Significantly lower total cost of ownership over a five-year period as compared with the alternative of upgrading and/or maintaining the existing software programs.

Staff recommends renewing the agreement with SADA for Google Apps for Government in an amount not to exceed \$25,200. SADA was selected in 2012 using an RFP process under the Village's purchasing regulations.

**EXTENSION TO THE GOOGLE APPS FOR
GOVERNMENT CUSTOMER AGREEMENT BETWEEN
