SYNOPSIS

A resolution has been prepared to authorize a two year extension to an agreement with MB Financial for banking services.

STRATEGIC PLAN ALIGNMENT

The goals for 2011-2018 include Exceptional Municipal Organization.

FISCAL IMPACT

There is no fiscal impact to the Village. The agreement with MB Financial states that compensating balances of \$2.7 million in the Village's cash accounts would result in a waiver of bank fees. This is the same method that the Village has been using since FY11 to pay for banking fees and is consistent with the FY15 budget.

RECOMMENDATION

Approval on June 16, 2015 Consent Agenda.

BACKGROUND

In July of 2012, the Village entered into a banking services agreement with Cole Taylor after an RFP process. In 2013, Cole Taylor merged with MB Financial. The original agreement was for three years, with the option of a two year extension. MB Financial has agreed to extend the contract for two years at the same pricing. The Village has been very pleased with the customer service provided by MB Financial.
