SYNOPSIS

A resolution has been prepared to authorize execution of a 1 year contract extension for future purchases of firefighter turnout gear from Air One, Inc. of Elgin, Illinois.

FISCAL IMPACT

No fiscal impact for 2015. The FY16 budget will include \$45,465 for the replacement of existing turnout gear and to purchase gear for new employees.

RECOMMENDATION

Approval on the July 21, 2015 consent agenda.

BACKGROUND

In 2012, the Village entered into a three-year agreement with Air One Equipment for the purchase of turnout gear. The contract, which included annual price increase of 3.5%, expired this year. Air One has agreed to extend the existing agreement for an additional year at a price increase of 1.9%. Staff anticipates purchasing 17 sets of turnout gear for members in the next year. This gear is at the end of its service life due to age and wear. Air One Equipment has been utilized by the Fire Department for past purchases of turnout gear has provided problem-free customer service.
