Estimate 2015 Aggregate Tax Levy for the Village of Downers Grove	Judy Buttny Finance Director

SYNOPSIS

A motion is requested to determine the tax levy estimate upon the taxable property in the Village in accordance with State law, which requires this action no less than 20 days prior to the adoption of the aggregate tax levy. The motion additionally directs staff to prepare ordinances to abate the preliminary tax levies related to the 2015 tax levies

STRATEGIC PLAN ALIGNMENT

The goals for 2011-2018 include Steward of Fiscal and Environmental Sustainability.

FISCAL IMPACT

The Village portion of the property tax levy after abatements is \$12,303,584, which is consistent with the FY2016 Budget as adopted on November 3, 2015. The total aggregate levy prior to abatements is \$26,111,393, which also includes levies for the Downers Grove Public Library and Special Service areas. The process for adopting the levy and difference between these figures is explained below.

BACKGROUND

The tax levy process requires the adoption of the estimated aggregate tax levy in advance of the following:

•	Publication of Truth in Taxation Notice and Announcement of Public Hearing	11/18/15
•	Public Hearing on Tax Levy	12/01/15
•	Adoption of Tax Levy	12/08/15
•	Abatement of Certain Debt Levies	12/08/15
•	Last day to file Levy with the County	12/29/15

Annually, the Village Council is required to levy taxes for the following:

- Village operations defined as corporate/police and fire protection;
- Police and Fire pension;
- Village General Obligation (GO) bond payments;
- Library operations;
- Library General Obligation bond payments; and
- Special Services Areas.

Following the levy of taxes, the Council may *abate* or reduce the levy (reduce the property tax collections) for the specific amount for which the Village has other resources available to pay for debt service. The following dedicated revenue sources are included in the FY2016 budget and allow for the abatement of GO bond payments as shown in the table below:

- Gasoline tax revenues budgeted for bonds issued to improve Fairview Avenue;
- Water revenues budgeted for bonds issued to improve the water system;
- Fund balance in the Library Debt Service Fund available to pay for a portion of the debt service related to library improvements completed in the mid-1990's; and
- Stormwater, capital and Tax Increment Financing (TIF) fund revenues budgeted for all remaining GO Bond payments.

The estimated levy, shown before and after abatements, is presented in the table below. The Village portion of the levy after abatements is \$12,303,584. All figures presented below are consistent with the FY2015 Budget.
