Village Response to Winter Storm Expected Late Saturday

A storm system will bring a variety of winter weather to the region Saturday afternoon into Saturday night. Public Works will continue to monitor the weather conditions through the day Saturday and respond accordingly.

The Village expects to respond to the snow event with a minimum of 14 plow drivers. Two fleet mechanics will be on-hand to respond to any equipment issues. All front-line snow removal equipment is in service. Adequate supplies of salt are also on-hand to respond to this event. At this point, Public Works expects to mobilize snow removal crews late Saturday afternoon (weather dependent) and work throughout the duration of the storm until snow operations are complete.

Staff expects the snow to begin between 3:00-5:00 p.m. from southwest to northeast. The snow will start off wet, but transition to a dry snow after 7:00 p.m. The snow will end around 2:00-4:00 a.m. Sunday. Temperatures will fall to about 25 degrees around midnight and about 15 degrees early Sunday. The winds will increase with gusts from the northwest about 35 mph by midnight tomorrow night. Gusty winds will continue into most of Sunday, causing blowing and drifting snow.

Accumulations of snow on paved surfaces are expected to range from 1 to 3 inches with the least in the northwest part of the metro area and highest amounts in the south into Northwest Indiana. Just south of I-80, snowfall may reach 3-5 inches. The following graphic is provided from the National Weather Service.
