SYNOPSIS

A resolution has been prepared to authorize a contract extension with TNT Landscape Construction, Inc. of Elgin, Illinois for sod installation and restoration services until December 31, 2016. There is no change in contract cost for this extension for a contract total not to exceed \$73,580.

STRATEGIC PLAN ALIGNMENT

The goals for 2015-2-17 include *Top Quality Infrastructure*.

FISCAL IMPACT

The FY16 budget includes \$70,000 in the Water Fund for street and parkway repairs required due to water utility excavations, and \$10,000 in the Storm Water Fund for sod installation for roadside ditch maintenance.

RECOMMENDATION

Approval on the February 9, 2016 consent agenda.

BACKGROUND

The contract amount is based on water utility repairs of approximately 650 square yards of topsoil and sod, and the placement of 9,300 square yards of sod from roadside ditch maintenance. The vendor has agreed to extend the contract until December 31, 2016.
