## A RESOLUTION SUPPORTING RESTORATION OF FUNDS FOR THE MEALS ON WHEELS PROGRAM

WHEREAS, Meals on Wheels is a vitally important program, providing hot meals and wellness checks to many homebound seniors in Downers Grove; and

WHEREAS, these services allow seniors to continue living independently in their own homes; and

WHEREAS, the Village of Downers Grove supports Meals on Wheels in DuPage County, allocating funds to help provide these services within the Village; and

WHEREAS, the State of Illinois has not provided full funding to Meals on Wheels throughout the State of Illinois; and

WHEREAS, this funding interruption has seen temporary reductions of Meals on Wheels home delivery from five (5) deliveries per week to two (2) deliveries per week in DuPage County; and

WHEREAS, these reductions imperil the well-being of seniors in Downers Grove, DuPage County and across Illinois; and

WHEREAS, the partial restoration of funds for Meals on Wheels does not safeguard this vital program from further cuts or interruptions in funding;

NOW, THEREFORE, BE IT RESOLVED that the Village of Downers Grove urges the Governor and the General Assembly to fully fund Meals on Wheels for Fiscal Year 2016 and future years to protect the well-being and independence of the thousands of senior citizens who rely on this program.

BE IT FURTHER RESOLVED that the Village Clerk be and is hereby authorized and directed to forward this Resolution to all local State legislators and urge them to support the Meals on Wheels program.
