| Contract Extension for Storm Sewer Closed Circuit Television Inspection and Cleaning | Nan Newlon Director of Public Works |

SYNOPSIS

A resolution has been prepared to authorize a contract extension with Visu-Sewer of Illinois, LLC of Bridgeview, Illinois, until December 31, 2016 for the provision of storm sewer closed circuit television (CCTV) inspection and cleaning services. The contract price shall increase by 2%, which is an increase of \$1,608.54 for a total not-to-exceed price of \$82,035.54.

STRATEGIC PLAN ALIGNMENT

The goals for 2015 to 2017 include *Top Quality Infrastructure*.

FISCAL IMPACT

The FY16 budget includes \$80,000 for this project.

RECOMMENDATION

Approval on the March 1, 2016 consent agenda.

BACKGROUND

This project is a component of the 2016 Stormwater Maintenance Program. The scope of this project includes CCTV inspection and cleaning of approximately 20,000 linear feet of storm sewer pipes. This work was competitively bid in 2014 and the contract allows for two extensions if approved by both parties. Visu-Sewer provided good service to the Village in 2014 and 2015 and staff recommends an extension of this contract.

**A RESOLUTION AUTHORIZING EXECUTION OF AN EXTENSION TO THE CONTRACT

4. That all resolutions or parts of resolutions in conflict with the provisions of this Resolution are hereby repealed.

5. That this Resolution shall be in full force and effect from and after its passage as provided by law.

**EXTENSION TO THE CONTRACT BETWEEN
THE VILLAGE OF DOWNERS GROVE AND
VISU-SEWER OF ILLINOIS, LLC**

The Village of Downers Grove, Illinois and Visu-Sewer of Illinois, LLC ("Provider") entered into a contract for CCTV inspection and cleaning on or about July 1, 2014. Pursuant to the terms stated therein, the parties desire to extend that contract under the following terms:

1. The contract shall be extended through December 31, 2016.
2. The fees shall increase by 2%, which is an increase of \$1,608.54, for a total not-to-exceed new price of \$82,035.54 for 2016.
