BACKGROUND

Commissioner White requested that the Village Council consider a proposal to direct staff to prepare a motion to establish a SWU Referendum Committee. The proposal is:

Move to establish a SWU Referendum Committee consisting of two council members and one member of the Stormwater and Floodplain Oversight Committee as selected by the Mayor (and confirmed by Council) along with members of staff as selected by the Village Manager. Staff members of the committee shall be non-voting.

This committee will be tasked with developing proposed language for one or more advisory referendum questions on whether to fund stormwater capital improvements with SWU fees or with [specified] or [unspecified] tax revenues.

This committee shall not propose referendum questions related to whether to impose a SWU fee to pay for current Operations and Maintenance found in the Stormwater Fund budget.

The committee shall report back to Council not later than July 1, 2016 with the objective of placing approved referendum questions on the November 2016 ballot.
