#### **SYNOPSIS**

Staff is providing a report for the FY15 General Fund. An ordinance has been prepared to amend the Village Budget for FY15 to reflect expenses that were not foreseen at the time the budget was adopted. This amendment is needed because the Village refunded stormwater bonds in FY15 to capture savings resulting from favorable interest rates. This refunding is recorded both as an expense and a revenue.

#### STRATEGIC PLAN ALIGNMENT

The goals for 2011-2018 identified Steward of Financial and Environmental Sustainability.

#### **FISCAL IMPACT**

Approval of this ordinance has no actual fiscal impact. The ordinance is required to bring the budgeted amounts in line with actual expenses.

#### **BACKGROUND**

The Village's FY15 Budget was authorized by ordinance in November 2014 and the Village's fiscal year began on January 1, 2015 and closed on December 31, 2015.

### General Fund Final Report

The FY15 budget was balanced with revenues at \$44.82 million and expenses at \$44.82 million. Actual expenses were under budgeted levels by \$700,000. Revenues were greater than the budget by \$840,000.

The following table shows the budgeted vs. actual revenues and expenses for the General Fund.

The higher-than-anticipated revenues were driven by the following:

State Income Tax: \$450,000 higher
Local Use Tax: \$250,000 higher
Sales Tax: \$144,000 higher

• Licenses and Permits: \$110,000 higher due primarily to strong activity in permits

When, as a result of unforeseen circumstances, expenses in any of the Village's funds exceed the amount authorized in the budget ordinance, the Village is required by law to pass an amendment to the budget ordinance to adjust the budget for the expenses. No amendments are required for revenues. The explanation for the amendment required is provided below, followed by a table.

Stormwater Fund: Increase expenses and revenues by \$2,300,000 for the refunding of the Stormwater bonds which resulted in \$520,000 of present value savings to the Village in debt service payments. This is due to the accounting entry required to show the proceeds from the new lower interest rate bond going into the fund (revenue entry) and paying off the old higher interest rate bond coming out of the fund (expense entry).

# AN ORDINANCE PROVIDING FOR AN AMENDMENT TO ORDINANCE #5412 AND THE VILLAGE OF DOWNERS GROVE BUDGET FOR FISCAL YEAR 2015
