SYNOPSIS

A motion is requested to authorize a contract amendment to an existing contract for Design and Oversight for Parking Deck Rehabilitation and Maintenance with Walker Parking Consultants/Engineering, Inc. dba Walker Restoration Consultants, of Elgin, in the amount of \$4,200.

STRATEGIC PLAN ALIGNMENT

The Goals for 2011 to 2018 identified Top Quality Infrastructure.

FISCAL IMPACT

This proposed contract amendment would increase the existing contract amount from \$42,460 to \$46,660. The FY16 budget includes \$50,000 in the Parking Fund for consultant services for design and construction oversight for this project.

RECOMMENDATION

Approval on the May 10, 2016 consent agenda.

BACKGROUND

The Village approved a contract with Walker Parking Consultants/Engineering, Inc. dba Walker Restoration Consultants for design and oversight for parking deck rehabilitation and maintenance on March 22, 2016. Project meetings have been conducted and preliminary design is underway. The contract includes assessment and re-design of the aging security callboxes throughout the parking deck, however, does not include assessment and design of the security camera system. Based on preliminary design discussions with Walker Parking Consultants and their sub-consultant who specializes in security systems, and in consultation with the Police Department, it was determined to be in the Village's best interest to increase the scope of the work to include an assessment and design for an upgrade to the existing camera system concurrently with the security callbox system.

This proposed contract amendment will increase the scope of the contract with Walker Parking Consultants to include assessment of the current camera security system, design of an upgraded system, and construction administration.

- 4. Incorporate information into a single (1) finalized version of the report.

1. Jensen Hughes will provide design services which include bid drawings and specifications for the surveillance system.

BIDDING PHASE

1. Jensen Hughes will provide assistance throughout the bidding phase which shall be inclusive of the surveillance system.

CONSTRUCTION ADMINISTRATION

1. Jensen Hughes will provide Construction Administration services which shall be inclusive of the surveillance system.
