SYNOPSIS

A motion is requested to authorize a change order to an existing three-year contract for Tree and Stump Removal services to Homer Tree Care, Inc. of Lockport, Illinois in the amount of \$60,000.00.

STRATEGIC PLAN ALIGNMENT

The goals for 2015 to 2017 include Exceptional Municipal Services.

FISCAL IMPACT

The FY16 budget includes \$71,000 in the General Fund. The amount of the proposed change order would increase the FY16 contract amount from \$155,747.80 to \$215,747.80. Funding is available to cover the cost of the change order as a result of savings from other Forestry contracted services.

RECOMMENDATION

Approval on the August 2, 2016 consent agenda.

BACKGROUND

In November 2015, the Village awarded a three-year tree and stump removal contract to Homer Tree Care, Inc. of Lockport, Illinois, in the amount of \$467,243.40 (\$155,747.80 per year). So far in 2016, the number of declining and dead ash trees is greater than anticipated. At this time staff has identified and marked ash trees in need of removal and recommends that an additional 200 trees beyond what can be removed with the existing contract be removed in 2016. This will reduce the number of trees in a poor condition over the winter that will be subject to winter storm damage.

Replacement tree plantings are ongoing and expected to surpass the original 650 estimated. In the spring, 335 trees were planted and more than 320 are planned for this fall. Any trees that are removed and not included on this fall's planting list will be replaced next spring.
