1. Call to Order

Mayor Martin Tully called the regular meeting of the Village Council of the Village of Downers Grove to order at 7:00 p.m. in the Council Chambers of the Downers Grove Village Hall.

2. Swearing-in Ceremony

Mayor Tully thanked Judge Walsh for attending the meeting and swearing in the new Commissioners.

Mayor Tully then noted that the Downers Grove Public Library recently engaged a new director. He then introduced Julie Milavec.

Ms. Milavec said she is excited to be here and noted that the Library is starting work on a new strategic plan and hopes to engage the public in this process.

6. Public Comments

This is the opportunity for public comments.

1. Bill Wrobel, 7800 Queens Court, said that in July and August while attempting to grow some vegetables, he would get up rather early. Between the hours of 6:00 a.m. and 8:30 a.m., there has been a proliferation of airplanes overhead from Southwest Airlines coming from Midway Airport. Apparently the aviation patterns are changing based on a decision made by Mayor Emmanuel. He said that the Village is a member of the DuPage Mayors and Managers Conference and he thinks that the Village could take the initiative on this issue. It is a disturbance, and he asked that people address the Council with respect to this matter. He also said that people in Willowbrook are experiencing the same problem.

Mayor Tully said that his verbal request would suffice for the Village to follow-up on this issue. The Village has representatives on O'Hare's Noise Commission. Sometimes there is a reason for a change in the flight patterns. Staff will look into this.

2. David Olsen, 5613 Dunham, said it is an honor for him to address the Council. He congratulated Commissioners Earl and Walus. He said as a former member of the Village Council it is an honor to serve the Village and he is happy to be of assistance to them and to the Village. He noted that it is a difficult position and is a great honor to serve.
