## **Meeting Minutes**

#### 1. Call to Order

Mayor Martin Tully called the regular meeting of the Village Council of the Village of Downers Grove to order at 7:00 p.m. in the Council Chambers of the Downers Grove Village Hall.

Pledge of Allegiance to the Flag

Mayor Tully led those present in the Pledge of Allegiance to the Flag.

## 2. Roll Call

The Council meeting is broadcast over the local FM radio station, WDGC. In addition, a tape recording and videotape of the meeting are being made using Village-owned equipment. The videotape of the meeting will be used for later rebroadcast of the Council meeting over the Village cable television Channel 6.

The Council will follow the rules of conduct for this meeting as provided in Sec. 2.5 of the Downers Grove Municipal Code. These offer the public the opportunity to comment at several points in the meeting. First, immediately following approval of the minutes of past meetings, an opportunity will be given for public comments and questions of a general nature. If a public hearing is scheduled for this meeting, an opportunity is given for public comments and questions related to the subject of the hearing. Finally, an opportunity is given for public comments and questions on items appearing on the Consent Agenda, the Active Agenda and the First Reading.

The Mayor stated that at the appropriate time the presiding officers will ask if there are any comments from the public. Individuals wishing to speak, should raise their hand to be recognized and, after acknowledgment from the presiding officer, approach the microphone and state their name. Remarks should be limited to five minutes, and individuals are asked to refrain from making repetitive statements.

Mayor Tully said there are agendas located on either side of the Council Chambers, and he invited the audience to pick up an agenda and follow the progress of the Council meeting.

**Motion:** Commissioner White, seconded by Commissioner Waldack, moved to approve the minutes as presented.

Mayor Tully declared the motion carried by voice vote.

## 4. Proclamation

Mayor Tully read a proclamation honoring the 150<sup>th</sup> anniversary of the First United Congregational Church of Christ in Downers Grove. He reviewed the history of the Church and its role in the Underground Railroad in Downers Grove, as well as the numerous charitable and social endeavors of the Church throughout its history.

The Mayor presented the Proclamation to Pastor Scott Oberle. Pastor Oberle thanked the Mayor and said it has been with great pride and honor that he has served to be part of a church that has been part of the Village since it was a grove. He thanked the Village for recognizing the church.

Mayor Tully thanked the Pastor for his comments and for all those attending tonight's meeting. He congratulated the congregation on behalf of the Village of Downers Grove.

## 5. Public Comments

This is the opportunity for public comments.

Matt Novak, 805 Summit, expressed his congratulations to the new members of the Council. He said he had a few items to discuss, the first concerning the Police Department. The Downers Grove Police Department has an excellent reputation. Mr. Novak is a patrol officer in another suburb and has heard that the Downers Grove Police Department has been without a contract for over two years. He said that the Village officers should be taken care of. There are many issues in policing today that are internal. The morale of the Downers Grove Police Department is tanking. He commented that often there is lack of communication that exists internally that has to be addressed. He asked that someone from the Council speak to the police officers and negotiators to get the situation of a contract remedied.

Mr. Novak then commented on the issue of community policing, referencing the Coffee with a Cop, which is a fantastic organization that helps build a bond between law enforcement and the citizens. He also mentioned that in May 2017 the Special Olympics fundraising, Cop on a Rooftop, will take place at Dunkin Donuts. He wanted people to be aware of this organization and this event that raised more than \$2.5 million last year.

Mr. Novak expressed concerned to the Council about the home at 5309 Lyman Avenue, which is a house that has been abandoned for 2-1/2 years and is for sale near Randall Park. The house is in an LPDA and is becoming an eyesore with drainage issues. There are skunks living in the garage. He asked that the Village look at the property to see what can be done, and whether this is a property that could be purchased by the Village and demolished to improve the drainage issues in that area.

Mayor Tully replied by thanking Mr. Novak for his comments. With regard to 5309 Lyman, the Council will consider the request he made. This may not be a good opportunity for acquisition. With regard to community policing, Chief Bluder and his department take the lead on that program. And as to the police contract, that is a collective bargaining issue. He said, however, that the Council is not holding up the contract. He has been with the Village Council since 2001 and the Village has always been involved in negotiating in a respectful manner.

The Downers Grove Police Department has and will have the full support of the Village Council. The Police Department is accredited by the Commission on Accreditation for Law Enforcement (CALEA) and, except for facilities, achieves excellence in all areas when evaluated. He knows first-hand the excellence this department has achieved, and noted that negotiations are a give and take situation.

Mr. Novak asked if contract negotiations have entered into arbitration. The Mayor said they may be in the process of arbitration. Mr. Novak commented that the residents want the police taken care of.

## 8. First Reading

Village Manager Dave Fieldman said that all four items under the First Reading have to do with the property at 1401-1445 Ogden Avenue. He asked Community Development Director Stan Popovich to provide information on these items.

**ORD 2016-6951** — A. Ordinance: Rezone Certain Property Located at 1401-1445 Ogden Avenue

Stan Popovich, Director, Community Development, said that these ordinances concern the property commonly known as Delta Sonic. The alley vacation requested is south of the property. He noted that there are five curb cuts presently on Ogden Avenue and two on Oakwood Avenue. The west side of the property is vacated by Burger King, which was purchased by Delta Sonic. He showed slides of the existing building, the stacking area, etc. The petitioner is proposing to redevelop the property with two curb cuts on Ogden Avenue, the installation of new canopies for the fuel pumps along Ogden Avenue, and include new construction and stacking for the car wash. He said that additional parking would be provided. Stormwater detention for the site will be underground, and no new stormwater detention is required. He showed a slide of the north and east elevations as well as a cross-section of the west side. With regards to the Comprehensive Plan, this meets requirements in that it will reduce curb cuts, and provide a pedestrian connection. The site meets the PUD, rezoning, special use and alley vacation criteria.

Mayor Tully said that basically they are expanding their existing use. The site has long been a challenging spot, and the expansion is a good thing.

Commissioner Earl said that she is thrilled that the curb cuts are being reduced and happy with the installation of the sidewalk.
