SYNOPSIS

A resolution has been prepared to amend the contract with Thompson Elevator Inspection Services, Inc. for elevator inspections, testing and plan review services by increasing the not-to-exceed amount from \$22,800 to \$35,000.

STRATEGIC PLAN ALIGNMENT

The goals for 2015 – 2017 include *Exceptional Municipal Services*.

FISCAL IMPACT

There is no net impact as this expense is reimbursed through elevator fees paid by the property owner.

RECOMMENDATION

Approval on the November 15, 2016 consent agenda.

BACKGROUND

The Village entered into a contract with Thompson Elevator Inspection Services, Inc. for elevator inspections, testing and plan review services on January 21, 2014. The 12-month contract has been extended twice. The contract was for a not-to-exceed amount of \$22,800 per year. The majority of Thompson's work is completing required annual elevator inspections. The Village has seen an increase in re-inspections of elevators as the State of Illinois has recently enacted new elevator upgrade requirements. As such, the Village is requesting the contract be amended to provide a not-to-exceed amount of \$35,000 for this year. All of these expenses are recaptured through elevator fees paid by the property owners.
