8. First Reading

ORD 2016-7131 — A. Ordinance: Authorize the Extension of a Special Use to Permit an Animal Boarding Facility at 941 63rd Street to May 10, 2017

Stan Popovich, Director, Community Development, showed the location of the property, noting there is an existing veterinary clinic on the site. On November 10, 2015, the Council approved a proposal for a new veterinarian care clinic. The petitioner is pursuing a building permit; however, a private law suit has been filed against the petitioner to enforce a private deed restriction on the property. This suit is still is pending and the Village cannot issue a permit for the development until the suit is resolved.

Commissioner Waldack noted that the Village does not recognize deed restrictions so this matter has to go through the courts. If the Village does not grant an extension, the petitioner would have to re-file their petition. He asked if there are any alternatives.

Mr. Popovich said it would be necessary to modify the Zoning Ordinance.

Mayor Tully said it is not uncommon to get this type of request. He feels this is a reasonable request.

Mr. Popovich showed the location of the property. On November 10, 2015, the Council approved a proposal to construct a five-story mixed use building at 904-910 Curtiss Street. The petitioner has submitted a building permit application, and is currently finalizing financing to complete the project.

ORD 2016-7132 — C. Ordinance: Amend Certain Parking and Traffic Regulations

Nan Newlon, Director, Public Works, said this ordinance makes four changes to various sections of Chapter 14 of the Municipal Code: 1) Section 14.4 would be amended to allow the Village Manager to approve the suspension of traffic regulations for up to 180 days, with one extension of an additional 180 days. 2) All references to the Main and Maple parking lot would be deleted as the parking lot no longer exists. 3) "No Parking" restrictions would be put into effect on Loomes Avenue and Bates Place between the hours of 8:00 a.m. and 11:00 a.m. 4) Phase 1 of the conversion of yield signs to stop signs would take place at four intersections. Ms. Newlon said Council will see more of the sign change requests in the future.

10. Manager's Report

INF 2016-7150 — A. Information: Stormwater Fund Revenue Decision.

Mr. Fieldman said residents voted on three stormwater advisory referenda questions at the November 8 election to help the Council determine how the cost of owning and operating our stormwater management system will be paid – fees, property tax, or a combination of both. Overwhelmingly, voters indicated a preference to remain on the stormwater utility fee-based system rather than use property taxes to cover stormwater costs. Based on that, the Council provided direction last week to keep the fee-based system in place and not to use property taxes to cover costs of stormwater related expenses. The direction provided by the Council is consistent with the results of the advisory referenda. The next step will be to consider any potential changes to the fee amounts. That will be presented next month in order that they be in place in 2017.

Mr. Fieldman noted that the public engagement campaign was extensive. He thanked staff who worked on this.

Mayor Tully said the information campaign was impressive. He was struck by the number of people who used the calculator. Mr. Fieldman said over 5,000 people used it.

Mayor Tully also noted that the short-form videos were brilliant. They were a very effective way to get across key points.

11. Attorney's Report
