**SYNOPSIS**

A resolution has been prepared to authorize a contract extension with to K – Five Construction Corporation., of Westmont, Illinois for supply of hot asphalt until December 31, 2017. The contract price shall increase by 2% which is an increase of \$1000 for a total not to exceed amount of \$51,000.

**STRATEGIC PLAN ALIGNMENT**

The goals for 2015-2017 include *Top Quality Infrastructure*.

**FISCAL IMPACT**

The FY17 Budget includes \$120,000 in the Capital Projects Fund (Page 4-29, Line 16) for the supply of hot asphalt.

**RECOMMENDATION**

Approval on the January 24, 2017 consent agenda.

**BACKGROUND**

This purchase provides for 1,000 tons of materials to be used for street repairs at various locations throughout the Village. Asphalt is used by Village crews for pothole and minor street patching as well as restoring driveway approaches that are excavated during the roadside ditch maintenance program. Village staff picks up the material at K-Five's Romeoville and Hodgkins plants as needed. Annual street repair work will begin in May and continue through October.

3. That the proper officials, agents and employees of the Village are hereby authorized and directed to take such further action as they may deem necessary or appropriate to perform all obligations and commitments of the Village in accordance with the provisions of the Agreement.

4. That all resolutions or parts of resolutions in conflict with the provisions of this Resolution are hereby repealed.

5. That this Resolution shall be in full force and effect from and after its passage as provided by law.


