SYNOPSIS

A resolution has been prepared to authorize a contract extension with Elmhurst Chicago Stone Company of Elmhurst, Illinois for supply of ready mix concrete through December 31, 2017. The contractor has agreed to extend the contract at the 2016 pricing for the not-to-exceed cost of \$15,450.

STRATEGIC PLAN ALIGNMENT

The goals for 2015-2017 include *Top Quality Infrastructure*.

FISCAL IMPACT

The FY17 Budget provides \$20,000 in the General Fund (Page 4-3, Line 16) for this contract extension.

RECOMMENDATION

Approval on the January 24, 2017 consent agenda.

BACKGROUND

This contract was competitively bid in 2016. This contract will provide a total of 110 yards of ready mix concrete material to be used by the Public Works Department for street repairs at various locations throughout the Village. Concrete is used by Village crews to complete in-house sidewalk, curb and gutter repair, as well as some stormwater system maintenance. Annual street repair work will begin in April and continue through October.

**A RESOLUTION AUTHORIZING EXECUTION OF AN EXTENSION

4. That all resolutions or parts of resolutions in conflict with the provisions of this Resolution are hereby repealed.

5. That this Resolution shall be in full force and effect from and after its passage as provided by law.
