SYNOPSIS

A resolution has been prepared to authorize execution of a one-year contract extension with B&F Construction Code Services, Inc. of Elgin, Illinois for building, plumbing, electrical, mechanical and energy inspections at a rate of \$75 per hour with a not to exceed amount of \$25,000.

STRATEGIC PLAN ALIGNMENT

The goals for 2015-2017 include Exceptional Municipal Services.

FISCAL IMPACT

The FY17 budget includes \$25,000 in the General Fund (Page 4-3, Line 17) for this contract extension.

RECOMMENDATION

Approval on the February 14, 2017 consent agenda.

BACKGROUND

The Village currently has a one-year contract with B & F Construction Code Services, Inc. of Elgin, Illinois to provide the necessary inspections associated with building permits when our full-time staff inspector is out of the office, or, to meet Village performance goals of performing inspections within 48 to 72 hours from the time of the request by the customer when demand is high. The contract includes two one-year extensions based on mutual agreement. The Village is exercising the first one-year extension.

B & F is a local leader in providing education, certification, plan review, and inspection services to the code community. In terms of their rates, efficiency, and availability they consistently outperform the competition. Their proposed hourly rate has remained unchanged over the last three years and their inspectors are courteous and knowledgeable.
