## **Cross-Connection Control Survey**

Every drinking water system in Illinois is required to have a cross connection control program, more commonly known as a backflow prevention program. Backflow prevention is designed to protect the public water supply from contamination from non-drinkable sources. Cross-connection hazards exist in a variety of places, such as factories, processing plants, laundries, dental offices and hair salons. Residential in-ground sprinkler systems are also capable of contaminating the public drinking water if they are not properly protected, for example.

One part of a backflow program is a bi-annual survey of all residential water customers. The survey asks water customers a few questions about the presence of potential cross connections created by lawn irrigation systems, fire sprinklers, boilers and hot tubs or in-ground pools. This year's survey is being sent to 15,125 single family homes and gives homeowners the option to reply by mail, fax or online. There are no consequences to homeowners for not replying, but everyone's cooperation helps protect the quality of the community's drinking water. It is expected that the survey will be received by homeowners within the next week. Customers that identify potential sources of backflow may be contacted by staff at a future date for follow up. The Village's next such survey will take place in 2019.

#### Dear Water Customer:

The Village of Downers Grove is dedicated to providing water to your home that is safe and clean. An important part of this is ensuring the effective control of cross connections. A cross connection is a point where your water supply pipe comes into contact with a source that could contaminate the water. Lawn irrigation systems, fire sprinklers, hot tubs/spas and in ground pools are examples of cross connections. If left unprotected, cross connections can allow contaminants or pollutants to enter the water system through "backflow". Backflow occurs when a drop in water pressure causes water to flow in the opposite direction, increasing the potential for contaminated water to flow back into the system.

To ensure the integrity of the water supply, the Village has established a Cross Connection Control program in compliance with Illinois Environmental Protection Agency (IEPA) requirements. Backflow Solutions, Inc. is a professional service company contracted by the Village to inspect the water supply and assist in the maintenance of this program.

Your participation in a comprehensive survey of the water system will help determine where cross connections exist. Please file your survey report online at www.bsiprograms.com/surveys. Alternatively, you may complete the below form and fax it to 888-414-4990.
