Meeting Minutes

Village of Downers Grove - Council Meeting

In order to give as many visitors as possible an opportunity to speak and in the interest of adjourning the meeting by 9:00 p.m., please limit your comments to 5 minutes in length, unless further time is granted by Council. Thank you.

1. Call to Order

Mayor Pro Tem William White called the regular meeting of the Village Council of the Village of Downers Grove to order at 7:00 p.m. in the Council Chambers of the Downers Grove Village Hall. He explained that Mayor Tully was out of town on business.

Pledge of Allegiance to the Flag

Mayor Pro Tem White led those present in the Pledge of Allegiance to the Flag.

The Council meeting is broadcast over the local FM radio station, WDGC. In addition, a tape recording and videotape of the meeting are being made using Village-owned equipment. The videotape of the meeting will be used for later rebroadcast of the Council meeting over the Village cable television Channel 6.

The Council will follow the rules of conduct for this meeting as provided in Sec. 2.5 of the Downers Grove Municipal Code. These offer the public the opportunity to comment at several points in the meeting. First, immediately following approval of the minutes of past meetings, an opportunity will be given for public comments and questions of a general nature. If a public hearing is scheduled for this meeting, an opportunity is given for public comments and questions related to the subject of the hearing. Finally, an opportunity is given for public comments and questions on items appearing on the Consent Agenda, the Active Agenda and the First Reading.

The Mayor Pro Tem stated that at the appropriate time the presiding officers will ask if there are any comments from the public. Individuals wishing to speak, should raise their hand to be recognized and, after acknowledgment from the presiding officer, approach the microphone and state their name. Remarks should be limited to five minutes, and individuals are asked to refrain from making repetitive statements.

Mayor White said there are agendas located on either side of the Council Chambers, and he invited the audience to pick up an agenda and follow the progress of the Council meeting.

3. Swearing-In Ceremony - Fire Chief Jeffrey Pindelski

Village Manager David Fieldman introduced new Fire Chief, Jeffrey Pindelski, and provided Chief Pindelski's biography and work history.

Village Clerk April Holden led the swearing-in of Jeffrey Pindelski as Fire Chief of the Village of Downers Grove.

Chief Pindelski said it was an honor to address the Council as Fire Chief of the Village. He thanked the Council, his family, friends and colleagues for the honor to serve. It is a distinct privilege to come to work everyday and join the people who make up the Downers Grove Fire Department team. The Fire Department patch symbolizes courage, pride, dedication, commitment and integrity in the highest regard, and guides every action that they take. He plans to uphold values and explore ways to serve our community even better. He promised nothing less than his best.

Mayor White commented on the importance of the Fire Department to the community. The Fire Department belongs to the ISO, and their ISO1 badge is objective evidence that Downers Grove's Fire Department is the best of the best. It is in the 99th percentile of performance. ISO stands for Insurance Services Offices, which is an independent private ratings agency that helps evaluate the strength of fire protection districts across the country on a wide variety of factors, and that helps insurance companies evaluate risk. It scores on a scale of 1-10 with 1 being superior. Of the approximately 2000 fire protection districts in Illinois, only 14 have an ISO1 rating, which is exceptional. Core services are the heart of why communities form governments. Chief Pindelski has accepted the responsibility of Fire Chief for the Village, and the community trusts that he and the Department will work to continue providing the Village with the best of the best.

8. First Reading

ORD 2017-7492 — A. Ordinance: Amend Provisions for Landmark Designation Filing

Community Development Director Stan Popovich explained that this Ordinance makes it easier for homeowners to add information to their already landmarked homes. Staff has consulted with the State and they have a supplemental listing record. This amendment will amend the definition section, and the petitioners will submit a supplemental listing record. It is merely a means of process simplification.

Commissioner Waldack said that this makes complete sense, and he is happy it is being brought forward.

- 1. Charlene Holtzen, 5226 Carpenter said they are the reason staff has brought this forward, and she said they appreciate the support of the Council.
- 2. Rich Kulovany, 6825 Camden Road, said he supports this as additional research often results in a need to alter the original landmarking application to include additional historical information for posterity.

RES 2017-7491 — B. Resolution: Grant Historic Landmark Designation for 4714 Oakwood Avenue

Mr. Popovich described the subject property as the Earl H. Prince home in the E.H. Prince subdivision. The home is a Queen Anne style. He showed photographs of the home going back to 1915, as well as its current status today, with a bay window and cross gables. The home meets the criteria of age, is connected with Earl Henry Prince, and meets the standards of a Queen Anne style home. He then played a brief video of the home prepared by the petitioner providing a history of Earl Henry Prince and the E.H. Prince subdivision.

- 1. Cindy Zaeske, 1130 Franklin, spoke on behalf of Ruth and John Wander who were out of town. She expressed their wish to have the property landmarked so that the community will have a reminder of its forefathers. "We shape our buildings; thereafter, they shape us." Winston Churchill
- 2. Rich Kulovany, 6825 Camden Road, said he supports this. It is one of the 62 homes deemed to be significant in the 2013 survey. If any type of property should be protected, it's this type of property. The history and memories are destroyed if the home is destroyed.
- 3. Amy Gassen, 5320 Benton, commented that the most difficult part of landmarking a home is the decision to do it. This is a wonderful example of a Queen Anne style home. She said it was recently recognized by the Downers Grove Historical Society and Downers Grove Museum's Historic Home program.

The Mayor then commented that registration opens for FROG soon. Highlights include classes in fiction writing. Additional information can be found on dgfrog.org. There will also be a cupcake decorating class. Mayor White will be teaching the children a class about drones, and battle drones.

Mayor White then said that thinking about the Fire Department, Police Department and Village infrastructure, those are all core services. Commissioner Waldack had noted once that core services are there to protect the whole apple. Thomas Jefferson once said that people create governments to protect life, liberty and the pursuit of happiness. The core services of government are to protect life, liberty, property and the pursuit of happiness—the whole apple.
