SYNOPSIS

Public Hearing for the FY18 Municipal Budget

STRATEGIC PLAN ALIGNMENT

The goals for 2017-2019 include Steward of Financial, Environmental and Neighborhood Sustainability.

FISCAL IMPACT

The FY18 Municipal Budget will provide for all operational revenues and expenditures for the time period from January 1, 2018 through December 31, 2018.

UPDATE & RECOMMENDATION

This item was discussed at the October 3, October 10, 2017 and October 17, 2017 Village Council meetings and at Coffee with the Council on October 21, 2017. A public hearing is required prior to the adoption of the budget.

There is a change to the Proposed FY18 Budget in the Foreign Fire Insurance Fund Expense Budget. The Foreign Fire Board has proposed budgeting funds for the construction of a training facility at Fire Station #1 at a cost of \$185,000. This brings the Foreign Fire Proposed budgeted expenses to \$355,500. Details on the changes are attached.

BACKGROUND
