SYNOPSIS

A resolution has been prepared authorizing an extension to an agreement for OnBase with Hyland Software, Inc. of Westlake, Ohio in the amount of \$23,530.57.

The FY18 Proposed Budget provides \$24,000 in the General Fund (Page 4-3, line 18) for the software agreement.

BACKGROUND

OnBase is an enterprise content management (ECM) software with integrated imaging, document management, business process management, and workflow management in a single application. The Village has used this product since 2004. Hyland, the manufacturer of OnBase, provides direct maintenance and technical support of all its products.

Since the OnBase installation, it has been used extensively by Village staff to move toward a paperless office environment. In 2017, staff began the conversion process of our previous agenda management software to unify past, present, and future Council documents.

The maintenance agreement is required on an annual basis.
