SYNOPSIS

A resolution has been prepared to authorize a contract extension for the provision of roadside drainage ditch reconstruction and maintenance services to Western Gradall Corporation of Naperville, Illinois in the amount of \$39,861.60.

STRATEGIC PLAN ALIGNMENT

The goals for 2017-2019 include *Top Quality Infrastructure*.

FISCAL IMPACT

The FY18 Budget includes \$40,000 in the Stormwater Fund (Page 4-21, Line 18) for roadside drainage ditch reconstruction and maintenance services.

RECOMMENDATION

Approval on the January 9, 2018 Consent Agenda.

BACKGROUND

The 2006 Storm Water Master Plan Update identified roadway drainage ditch cleaning (re-grading) as a key maintenance activity for the Village's storm water system. Work is planned to be performed between April and September of this year. The contract amount is based on approximately 7,000 linear feet of drainage ditch maintenance being completed in 2018.

**A RESOLUTION AUTHORIZING EXECUTION OF A SECOND EXTENSION
TO THE AGREEMENT BETWEEN

BE IT RESOLVED by the Village Council of the Village of Downers Grove, DuPage County, Illinois, as follows:

1. That the form and substance of a certain Second Extension (the "Agreement"), between the Village of Downers Grove (the "Village") and Western Gradall Corporation (the "Provider"), for roadside ditch maintenance services, as set forth in the form of the Agreement submitted to this meeting with the recommendation of the Village Manager, is hereby approved.

2. That the Village Manager and Village Clerk are hereby respectively authorized and directed for and on behalf of the Village to execute, attest, seal and deliver the Agreement, substantially in the form approved in the foregoing paragraph of this Resolution, together with such changes as the Manager shall deem necessary.

3. That the proper officials, agents and employees of the Village are hereby authorized and directed to take such further action as they may deem necessary or appropriate to perform all obligations and commitments of the Village in accordance with the provisions of the Agreement.

4. That all resolutions or parts of resolutions in conflict with the provisions of this Resolution are hereby repealed.

5. That this Resolution shall be in full force and effect from and after its passage as provided by law.

**SECOND EXTENSION TO THE CONTRACT BETWEEN
THE VILLAGE OF DOWNERS GROVE AND
WESTERN GRADALL CORPORATION**

The Village of Downers Grove, Illinois and Western Gradall Corporation ("Provider") entered into a contract for Roadside Ditch Maintenance Services on or about February 9, 2016. Pursuant to the terms stated therein, the parties desire to extend that contract under the following terms:

1. This is the second of two optional extensions and the contract shall be extended through December 31, 2018.
2. The fees shall increase by 2%, which is an increase of \$781.60, for a total not-to-exceed new price of \$39,861.60 for 2018.
3. All other terms from the February 9, 2016 contract remain in full force and effect.


