## SYNOPSIS

A resolution has been prepared to authorize a contract amendment to the existing B&F Construction Code Services contract to modify the not-to-exceed amount from \$25,000 to \$31,000.

# **FISCAL IMPACT**

The FY18 budget provides \$38,500 in the General Fund (Page 5-17, Line 3) for this contract.

## RECOMMENDATION

Approval on the January 16, 2018 consent agenda.

#### BACKGROUND

The Village has a contract through March 2018 with B&F Construction Code Services, Inc. of Elgin to provide the necessary inspections associated with building permits when Village staff is unable to complete inspections within 48 to 72 hours from the time of the request by the customer when demand is high.

In 2017, the Village saw continual high demand for inspections resulting in 4,757 completed inspections compared to 3,972 in 2016. A substantial portion of these additional inspections was completed by B&F. Based on the increased use of B&F, the Village requires the contract be amended to increase the available funding by \$6,000 to fund the remainder of the current contract. The Village anticipates extending the contract with B&F for another year when the contract expires in early March. The cost of these contracted services is offset by building permit and inspection fee revenue.
