SYNOPSIS

A resolution has been prepared to authorize a contract extension with KLF Enterprises of Markham, Illinois for the provision of debris hauling services until December 31, 2018. The contract price will increase by 2%, an increase of \$1,534.50, for a total contract amount of \$78,259.50.

STRATEGIC PLAN ALIGNMENT

The goals for 2017-2019 include *Top Quality Infrastructure*.

FISCAL IMPACT

The FY18 Budget includes a total of \$80,000: \$40,000 in the Stormwater Fund, Page (4-29, Line 18) and \$40,000 in the Water Fund (Page 4-35, Line 18) for this contract.

RECOMMENDATION

Approval on the February 6, 2018 consent agenda.

BACKGROUND

The contract amount is based on approximately 355 loads of debris required to be hauled for Public Works street, stormwater and water utility system maintenance. The vendor has agreed to extend the contract until December 31, 2018.

3. That the proper officials, agents and employees of the Village are hereby authorized and directed to take such further action as they may deem necessary or appropriate to perform all obligations and commitments of the Village in accordance with the provisions of the Agreement.

4. That all resolutions or parts of resolutions in conflict with the provisions of this Resolution are hereby repealed.

5. That this Resolution shall be in full force and effect from and after its passage as provided by law.


**EXTENSION TO THE CONTRACT BETWEEN
