One-day Main Street Crossing Closure

On Tuesday, February 20th, the Burlington Northern Santa Fe Railroad will close the Main Street crossing to replace a piece of rail within the crossing. The crossing is planned to be closed from approximately 8:30am to 2:30pm. A traffic detour will be put in place for the one day closure.

West Burlington Area Neighborhood Meeting

A neighborhood meeting was held at Public Works on Thursday evening to discuss planned 2018 drainage improvements for Area 7, as identified in the 2014 Stormwater Project Analysis (SPA) Report, and new sidewalk installation in the West Burlington Area. Project limits are Drendel Road from Ogden Avenue to Prairie Avenue, and Cross Street from Prairie Avenue to Burlington Avenue. The purpose of the meeting was to provide information to the residents about the drainage improvement and new sidewalk designs (currently at the 50% design stage), provide an estimated project timeline and to obtain feedback from residents. Twenty-one residents representing 15 properties attended the meeting. Staff noted concerns and questions during the meeting.

VODG SWFPOC Staff Report April 13, 2017

A. IAFSM

Three staff members attended the Illinois Association of Stormwater and Floodplain Managers (IAFSM) Annual Conference in March in Springfield, IL. Julie and Kerry (along with another engineer) presented "Redevelopment in Urban Flood-Prone Areas." Kerry moderated at one of the sessions. Julie was one of the presenters for a Local Officials Roundtable. Julie is the new Community Rating System (CRS) chair for IAFSM. The position was previously held by Karen Dalton-Lange. CRS provides a system by which communities can lower flood insurance for residents by enforcing requirements stricter than the National Flood Insurance Program (NFIP) minimum standards.

B. NPDES training

The Village of Downers Grove has a permit through the Illinois Environmental Protection Agency (IEPA)/National Pollutant Discharge Elimination System (NPDES) for Municipal Separate Storm Sewer System (MS4). The main goal of the program is to reduce pollutant discharges into the waterways. Kerry and Julie attended separate trainings for the NPDES (pollution control and documentation) and will be submitting the Annual Report by June 1.

C. Sustainable Design Challenge - April 4, 2017

Two staff engineers – Stephanie and Kerry – were judges at the annual Sustainable Design Challenge hosted by SCARCE and DuPage County. High school students teamed up to design a new building and incorporate sustainable design features such as permeable pavers, rain gardens, green roofs, etc.

D. Advanced Floodplain Management Training

Julie was at the National Emergency Training Center in Emmitsburg, MD April 2-7 for a FEMA course in floodplain management.
