SYNOPSIS

A resolution is requested authorizing execution of an addendum to an agreement for prosecution services between the Village of Downers Grove and Christine Charkewycz, Attorney at Law.

STRATEGIC PLAN ALIGNMENT

The goals for 2017-2019 include Exceptional Municipal Services.

FISCAL IMPACT

The cost for this one year addendum is \$28,519.20. The FY18 budget includes \$28,519.20 in the General Fund (Page 4-3, Line 17) for this service.

RECOMMENDATION

BACKGROUND

The Village entered into a three-year agreement with Ms. Charkewycz in May of 2015 to perform prosecution services. The current agreement expires May 31, 2018. Ms. Charkewycz prosecutes the Village's ordinance violation cases, including traffic and code enforcement violations. Ms. Charkewycz has provided excellent service for the past three years and staff recommends extending the agreement for an additional year with a 2% increase in fee.

ADDENDUM TO THE AGREEMENT FOR PROSECUTION SERVICES BETWEEN THE VILLAGE OF DOWNERS GROVE AND CHRISTINE CHARKEWYCZ, ATTORNEY AT LAW

The Village of Downers Grove, Illinois (the "Village") and Christine Charkewycz, Attorney at Law (the "Prosecutor") entered into an agreement for the prosecution of ordinance violations (the "Agreement") on or about May 12, 2015. Pursuant to the terms stated therein, the parties desire to amend the contract under the following terms:

- 1. Pursuant to Section 2, the contract price shall be increased an additional \$559.20 (2%) resulting in an annual flat fee of \$28,519.20 to be paid over a twelve (12) month period commencing June 1, 2018 and ending May 31, 2019.
- 2. Pursuant to Section 4, the agreement shall be extended for an additional one (1) year term or until May 31, 2019.
- 3. All other terms from the 2015 Agreement remain in full force and effect.
