Meeting Minutes

1. Call to Order

Mayor Pro Tem William White called the regular meeting of the Village Council of the Village of Downers Grove to order at 7:00 p.m. in the Council Chambers of the Downers Grove Village Hall. He explained that Mayor Tully is out of town on business and would not be in attendance at tonight's meeting.

Pledge of Allegiance to the Flag

The Council meeting is broadcast over the local FM radio station, WDGC. In addition, a tape recording and videotape of the meeting are being made using Village-owned equipment. The videotape of the meeting will be used for later rebroadcast of the Council meeting over the Village cable television Channel 6.

The Council will follow the rules of conduct for this meeting as provided in Sec. 2.5 of the Downers Grove Municipal Code. These offer the public the opportunity to comment at several points in the meeting. First, immediately following approval of the minutes of past meetings, an opportunity will be given for public comments and questions of a general nature. If a public hearing is scheduled for this meeting, an opportunity is given for public comments and questions related to the subject of the hearing. Finally, an opportunity is given for public comments and questions on items appearing on the Consent Agenda, the Active Agenda and the First Reading.

At the appropriate time the presiding officer will ask if there are any comments from the public. 4. Public Comments

This is the opportunity for public comments.

1. Amandalynn, a life-long resident of Downers Grove, informed the Council that last Tuesday she suffered a grand mal seizure while driving, and is not sure what happened. Her 11-year-old daughter called 911 and waved a stranger down who stopped. Her daughter, the stranger and police officers saved her life and stayed with her until the ambulance arrived. The officers who were there, Jay Johnson and Jeffrey Mertz, stayed with her and her daughter throughout. They were so patient and compassionate. She noted two paramedics from Lisle named Joshua Runge and Gary Pec who tried to keep her daughter calmed down. They made sure that everything was handled for her, including assuring that all of her belongings were transported with her. The police went above and beyond by going to her home to notify her family. So much good happened to her between the stranger, the Fire and Police personnel. She is trying to find the Good Samaritan who stopped to help in the situation as well.

Mayor White thanked her for coming and informing the Council and the public about what occurred. With Police and Fire personnel, seconds do count. Elected officials also need to be sure that public service departments get the resources that they need. He said no one should take for granted that the Village has an outstanding Police and Fire Department.

Amandalynn replied that she wanted to make sure that everyone knows how incredible these personnel were, and that she was going to visit the Fire Department and Police Department to thank the personnel personally for saving her and helping her daughter.

7. First Reading

RES 2018-7689 — A. Resolution: Grant Historic Landmark Designation for 1205 Franklin Street

Village Manager Dave Fieldman said that this resolution is for an historic landmark application northwest of the downtown area at Franklin and Saratoga. He called upon Community Development Director Stan Popovich to make the presentation.

Stan Popovich, Director, Community Development, said the home in question is a Queen Anne style building circa 1895 construction. He described many features of the Queen Anne house including the corner turret, and features on various elevations. He said that the proposal complies with the landmark criteria.

Mayor White asked as to the number of landmarked buildings.

Mr. Popovich said this is the first one this year.

- 1. Irene Hogstrom, 1232 Gilbert, expressed support for landmarking this home and thanked the owners for bringing their petition forward.
- 2. Rich Kulovany, 6825 Camden, noted his support for this petition, and thanked the owners for protecting their home as well.
- 3. Amy Gassen, 5320 Benton, noted that this is a centennial home and expressed her support of this petition.
- 4. Chuck Holtzen, 5226 Carpenter, commented that both she and her husband support landmarking this home.

8. Mayor's Report

Mayor White noted that on March 8 the Grove Foundation Passport to Dining will take place and is a wonderful event. He was unsure as to whether there were still tickets available but encouraged people to check the Grove Foundation for further information.

Mayor White then noted that was heartwarming to hear the story of public safety officials coming to the aid of the Downers Grove resident who spoke earlier at the meeting. He remembered that a short time ago the Village's Fire Department went above and beyond to pull someone out of broken ice. It is important not to take for granted the services provided by our public safety officials.
